PATTERN OF QUESTION PAPER ON THE UNIT SYSTEM

The pattern of question paper as per unit system will be broadly based on the following pattern.

- (1) Syllabus has been divided into units equal to the number of question to be answered in the paper. On each unit there will be a question either a long answer type or a short answer type.
- (2) Number of question will be in accordance with the unit prescribed in the syllabi for each paper i.e. there will be one question on each unit.
- (3) For every question long answer type or short answer type there will be an alternative choice from the same unit. However, there will be no internal choice in a question.
- (4) Division of marks between long answer and short answer type question will be in the ratio of 40 and 60.
- (5) Each short answer type question shall Contain 4 to 8 short sub question with no internal choice.

Whereas, the scheme of examinations and syllabi of Post Graduate Diploma in Co-operation course is to be made available for the Academic Session 2014-2015.

Now therefore, I Dr. M.K.Khedkar, Vice Chancellor, Sant Gadge Baba Amravati University in exercise of the powers conferred upon me under sub-section (8) of section 14 of the Maharashtra Universities Act, 1994, do hereby direct as under –

- 1. This Direction may be called "Examinations leading to the Post Graduate Diploma in Co-operation (Semester Pattern- One Year Course) in the Faculty of Commerce, Direction 2014.
- 2. This Direction shall come into force from the Academic Session 2014-2015.

- 3. The Examinations leading to the Post Graduate Diploma in Cooperation (Semester Pattern- One Year Course) shall be held at such places and on such dates as may be appointed by the Board of Examinations.
- 4. The duration of the diploma course shall be of one year.
- 5. The diploma course shall be conducted in two Semesters in one Academic Year.
- 6. Subject to the compliance with the provisions of this Direction and of any other Ordinances in force form time to time, an applicant for admission to the Examinations of the Post Graduate Diploma in Co-operation course shall have-
 - (i) Bachelor's degree of this University in any faculty or of any other Statutory University whose degree is recognized as equivalent thereto by the SantGadge Baba Amravati University.
 - Prosecuted the regular course of study for not less than one Academic Year in a college or department recognized for this purpose by the University.
- 7. Subject to his/her compliance with the provisions of this Direction and /or of any other Ordinances (pertaining to examinations general) in force from time to time, the applicant for admission to examination at the end of course of study of a particular semester shall be eligible to appear at it, if he/she satisfied the conditions in the table and the provision thereunder :-

- 8. Without prejudice to the other provisions of Ordinance No.6 relating to examinations in general, the provisions of Paragraphs 5,8,10 and 27 of the said Ordinance shall apply to every collegiate candidates.
- 9. The fees for the examinations and other shall be as prescribed by the University from time to time.
- 10. An applicant for the examination prosecuting a regular course of study to the P.G.Diploma course shall not seek admission to any other academic course in this or any other University.
- 11. The scope of the subjects shall be as indicated in the syllabus.
- 12. The scope of papers and detail scheme of teaching and examinations for theory and project shall be as indicated in Appendices A & B.
- 13. The medium of instructions and examinations for the course shall be English, Marathi & Hindi.
- 14. The internal marks shall be awarded by the Head of the College/ Department in consultation with the teachers as per the scheme provided under the scheme of examinations.
- 15. An Examinee who will unsuccessful at the examinations shall be eligible for admission to the examination on payment of a fresh fee prescribed for the Examination together with an Ex-Student Fee shall be as per Ordinance No.12, and on compliance with the conditions of the Ordinance in force from time to time.
- 16. An examinees who has failed at the sessional / project examination only shall be required to register himself afresh for doing the Sessional/Project work again in the College/Department concerned in the subject or subjects in which he so failed, on payment of a fresh examination fee as per Ordinance No.12. The Head of the Department/ College shall, on being satisfied about the completion of the sessional work/project of such a candidate, send the fresh sessional/project marks to the University and these sessional/project marks shall be taken into consideration for computing his result at the examination.
- 17. Successful examinees obtaining 60% or more marks in the aggregate at the examination shall be placed in the First Division.
- 18. The provisions of Ordinance No.18 of 2001 shall be applicable to the examinees of this course.

- 19. Notwithstanding anything to the contrary in this Direction, no person shall be admitted to a University Examination if he has already passed the same examination or an examination of another University which has been recognized as equivalent to that examination.
