Regulation No. 1 of 2014.

Operation of endowment fund for awarding Shri Jawaharlalji Darda Gold Medal (Amendment) Regulation, 2014.

Whereas it is expedient to amend the Regulation No. 3 of 2000 in respect of Operation of endowment fund for awarding Shri Jawaharlalji Darda Gold Medal i.e. Original Regulation for the purpose hereinafter appearing, the Academic Council is hereby pleased to make the following Regulation.

1. This Regulation may be called “Operation of endowment fund for awarding Shri Jawaharlalji Darda Gold Medal (Amendment) Regulation, 2014.”
2. This Regulation shall come into force w.e.f. the date of its passing by the Management Council.
3. (i) In para – 2 of Regulation No. 3 of 2000, the words & figures “Bachelor of Mass Communication examination from 2001-2002 academic session” be substituted by the words “Bachelor of Journalism and Mass Communication examination”
(ii) Sub Clause i) of clause – 3 of Regulation No. 3 of 2000 be substituted by “Specification of the Medal shall be as decided by the Management Council from time to time.”
(iii) In sub Clause iv) of clause – 3 of Regulation No. 3 of 2000, the words “Bachelor of Mass Communication” be substituted by the words “Bachelor of Journalism and Mass Communication.”
(iv) In sub Clause x) of clause – 3 of Regulation No. 3 of 2000, the words “Bachelor of Mass Communication” be substituted by the words “Bachelor of Journalism and Mass Communication.”

Regulation No. 2 of 2014.

Operation of endowment fund for awarding Patramaharshi Balasaheb Marathe Gold Medal (Amendment) Regulation, 2014.

Whereas it is expedient to amend the Regulation No. 26 of 1998 in respect of Operation of endowment fund for awarding Late Balkrishna Vishnu Alias Balasaheb Marathe Memorial Gold Medal i.e. Original Regulation for the purpose hereinafter appearing, the Academic Council is hereby pleased to make the following Regulation.

1. This Regulation may be called “Operation of endowment fund for awarding Patramaharshi Balasaheb Marathe Gold Medal (Amendment) Regulation, 2014.”
2. This Regulation shall come into force w.e.f. the date of its passing by the Management Council.
3. i) The title of Regulation No. 26 of 1998 be substituted by “Regulation for Operation of Endowment Fund for awarding Patramaharshi Balasaheb Marathe Gold Medal (Amendment) Regulation, 2014”
ii) In Para 1 of Regulation No. 26 of 1998 the words “Late Balkrishna Vishnu Marathe Alias Balasaheb Marathe Memorial” be substituted by the words “Patramaharshi Balasaheb Marathe”
iii) In Para 2 of Regulation No. 26 of 1998 the words “M.D. (Ayurved) examination” be substituted by the words & figures “Master of Journalism and Mass Communication examination”
iv) In Clause 1 of Regulation No. 26 of 1998 the words “Late Balkrishna Vishnu Alias Balasaheb Marathe Memorial” be substituted by the words “Patramaharshi Balasaheb Marathe”
v) Sub clause i) of Clause 3 be substituted by “Specification of the Medal shall be as decided by the Management Council from time to time.”
vi) Sub clause iv) of clause 3 be substituted by “Out of the total annual interest 10 % shall be deducted as Administrative Charges which shall be credited to the General Fund. One Gold Medal as mentioned in para 3 i) above shall be awarded at the Annual Convocation to a student who from amongst the successful candidates secures highest number of marks and stands first in order of merit in Master of Journalism and Mass Communication examination in a minimum period and in the first attempt in annual examination every year of the Sant Gadge Baba Amravati University.”
vii) In sub clause x) of clause 3 the words “Late Balkrishna Vishnu Alias Balasaheb Marathe Memorial” be substituted by the words “Patramaharshi Balasaheb Marathe” and the words “M.D. (Ayurveda)” be substituted by the words “Master of Journalism and Mass Communication.”
