**For Example :-** The students who have cleared B.Tech-I examination with old course (annual pattern) will be eligible for admission to Semester-III of new course (semester pattern). The marks obtained as per the old course will be converted to new course by applying following formula.

<b>I) For admission to B.Tech. Semester-III Cosmetics semester pattern :</b>	
Conversion of marks as per new course for Semester-I	= [marks obtained by students in old course (annual pattern) of B.Tech-I × Total marks of Ist Sem] divided by Total marks of B.Tech.Part-I old course
Conversion of marks as per new course for Semester-II	= [marks obtained by students in old course (annual pattern) of B.Tech-I × Total marks of IInd Sem] divided by Total marks of B.Tech.Part-I old course
<b>II) For admission to B.Tech. Semester-V Cosmetics semester pattern:</b>	
Conversion of marks as per new course for Semester-III	= [marks obtained by students in old course (annual pattern) of B.Tech-II × Total marks of IIIrd Sem] divided by Total marks of B.Tech.Part-II old course
Conversion of marks as per new course for Semester-IV	= [marks obtained by students in old course (annual pattern) of B.Tech-II × Total marks of IVth Sem] divided by Total marks of B.Tech.Part-II old course
<b>III) For admission to B.Tech. Semester-VII Cosmetics semester pattern:</b>	
Conversion of marks as per new course for Semester-V	= [marks obtained by students in old course (annual pattern) of B.Tech-III × Total marks of Vth Sem] divided by Total marks of B.Tech.Part-III old course
Conversion of marks as per new course for Semester-VI	= [marks obtained by students in old course (annual pattern) of B.Tech-III × Total marks of VIth Sem] divided by Total marks of B.Tech.Part-III old course
<b>IV) For admission to M.Tech. Semester-III (Cosmetics) semester pattern:</b>	
Conversion of marks as per new course for Semester-I	= [marks obtained by students in old course of M.Tech-I × Total marks of Ist Sem] divided by Total marks of M.Tech.Sem-I old course
Conversion of marks as per new course for Semester-II	= [marks obtained by students in old course of M.Tech-I × Total marks of IInd Sem] divided by Total marks of M.Tech.Sem-II old course
