It has been proved that this committee has promoted the human care of animals used in biomedical and behavioural research and testing. Recently the Ph.D research on “Validation of Antiurolithiatic Activity of Selected Ethnomedicinal Plants from Melghat Forest Region, Amravati District” supported by Rajiv Gandhi Science and Technology Commission, Mumbai has been approved by IACE on 14/5/2016 under the Chairmanship of Dr M.K. Rai and Dr B.R. Ramteke, main CPCSEA nominee (SGBAU/520/IAEC/DBT/2016/01). The promising results of lab experiments validated on mice and animal cell lines confirms the lithiatic activity (kidney stone breaking), and which again confirms the potential of purified plant metabolites as drug molecules. The MoU between the SGBAU and M/S Appropriate Diet Therapy centre was finalized and signed on 7/7/2020 for the further human trial and industrial production of same antilithiatic drugs. Thus the IAEC of SGBAU helps in confirming and finalization of plant drugs for human use. Dr Anita Patil, Biotechnology Dept is member secretary of SGBAU and CPCSEA nominee, Govt of India (F.No 25/8/2017 CPCSEA dated 6/4/2017). Dr Patil nominated on various IAEC of 03 research Institute, which ensures the scientific use of animals and also research contribution of SGBAU to other institute.


6. You are requested to convene the meeting of the constituted IAEC within 30 days and forward the Minutes of the meeting to the O/o CPCSEA, New Delhi.
