Subject :Norms and Procedure to be followed while nominating members on authorities, and committees by the Vice-Chancellor under the Maharashtra Public Universities Act, 2016, Direction, 2023

Whereas, the Maharashtra Public Universities Act, 2016 (hereinafter referred as the Act) came into force w.e.f. 1st March, 2017.

### **AND**

Whereas, various authorities of the university are provided under section 26 of the said Act.

#### **AND**

Whereas, various committees of the university are provided under respective provisions of the said Act.

### **AND**

Whereas, various authorities and committees are to be constituted by election and/or by nomination as per provisions under the said Act.

### **AND**

Whereas, the nominations by the Vice-Chancellor under the following provisions are required to be made.

"28(2)(v), 28(2)(y), 30(4)(d), (e) and (k), 32(3)(f)(i), (ii) and (iii), 38(1)(f), 40(2)(b)(i), (ii) and (iii), 42(2)(c) and (d), 44(3)(c) and (d), 45(3)(d), (e) and (f), 47(3)(g) and (h), 49(3)(f) and (g), 51(3)(d), (e) and (f), 53(3)(e), (f) and (g), 55(2)(c), (d) and (e), 57(2)(c), 59(2)(d), (e) and (f), 79(3)(a) and (b), 94(2)(e), 96(2)(b), (c) and (d), 98(2)(f), 99(2)(f), 100(2)(e) and (f), 101(3)(d) and (e), 102(2)(d), 104(d), 105(2)(d)"

## **AND**

Whereas, procedure relating nominations by the Vice-Chancellor on the authorities and committees is required to be regulated by the Statute as provided u/s 71(17) of the Act.

# AND

Whereas, Direction No. 42/2017, dt. 8.11.2017 in this regard, was issued by the Hon'ble Vice-Chancellor, which was converted into draft Statute No. 4/2021 and submitted to the Hon'ble Chancellor's office vide letter No. SGBAU/21/LegalCell/192/2021, dt. 5.5.2021 as approved by the Management Council and the Senate. The consent to the said draft Statute, from the Hon'ble Chancellor is yet to received;

Whereas, it is not possible to amend or make a new Statute in near future as the Statute Committee provided u/s 72 of the Act is yet to re-constituted;

#### **AND**

Whereas, making of Statute is a time consuming process,

Now, therefore, I, Dr. V.S.Chowbe, I/c Vice-Chancellor, of the Sant Gadge Baba Amravati University in exercise of powers conferred upon me u/s 12(8) of the Act, issue the following directions:-

- 1. This Direction shall be called "Norms and Procedure to be followed while nominating members on authorities, and committees by the Vice-Chancellor under the Maharashtra Public Universities Act, 2016, Direction, 2023"
- 2. This Direction shall come into force w.e.f. the date of its issuance.
- 3. In this Direction, unless the context otherwise requires
  - a) "Act" means the Maharashtra Public Universities Act, 2016
  - b) "Authorities" means authorities provided under section 26 of the Act.
  - c) "Committees" means committees provided under sections 79, 92, 102, 103, 104 and 105 of the Act.
  - d) "Eligibility conditions" means eligility conditions for being elected, nominated or co-opted as a member of any authority of the university in the light of provision made under section 27 by State Government from time to time.

The words and expressions used but not defined in this Direction shall have the same meanings respectively assigned to them in the Act.

4. In order to fulfill the nominations on the various authorities, the Registrar shall invite Bio-Data/Profile of the persons, on the directions of the Vice-Chancellor belonging to the respected categories, who fulfills category wise eligibility conditions, through public notification on the website of the university.

Every person desirous to be nominated shall have to enclose such documents along with his/her Bio-Data/Profile which may prove the fulfillment of the eligibility conditions in the related category. He/She shall also submit an undertaking in tune with the provisions of section 64 of the Act.

*Provided firstly* that, candidate should submit separate Bio-Data/Profile for each respective nomination/vacancy.

Provided secondly that, after centralised invitation called and published by the Registrar, the incharge Section Officer having the concerned authority or committee, should scrutinize the received Bio-Data/profile as per the respective provisions of the Act & the eligibility conditions given in this respect by the State Government and submit it before the Hon'ble Vice-Chancellor for their onwards process of nomination.

*Provided thirdly* that, the Vice-Chancellor may nominate such eligible persons who have not submitted their Bio-Data/Profile in response to the invitation of the Registrar.

5. Tenure of each nominated member shall be as provided in the related section of the Act.
