Exemption from the entrance test for admission to M.Sc.(Biotechnology) for the academic session 2020-2021, Direction – 2020.

Whereas, Ordinance No.4/2008 regarding Examination leading to the Degree of विज्ञान पारंगत (Master of Science) (Four Semester Degree Courses), Ordinance- 2008 teaching is in existence in the University.

AND

Whereas, the terms of entrance test for admission to M.Sc. Semester –1 (Bio-technology) is provided under the Direction No. 27/2010 as well as the Regulation No. 1/2020 and Rule No.5/2005.

AND

Whereas, the State Government directed time to time to avoid social gathering due to Covid- 19 pandemic, hence it is not possible to conduct the Entrance Examination Test for the year academic year 2020-21,

AND

Whereas, in view of the present scenario of Covid-19 pandemic, the Academic Council in its meeting held on 4.12.2020 vide item No. 95 approved the exemption from the entrance test for admission to M.Sc.(Biotechnology) for the academic session 2020-2021 and recommended to the Management Council for its final approval.

AND

Whereas, on behalf of the Management Council, the Hon'ble Vice-Chancellor approved the matter under section 12(7) of the Maharashtra Public Universities Act-2016.

AND

Whereas, it is imperative to the issuance of a fresh direction incorporating the provisions of exempting students from entrance test for admission to M.Sc. (Biotechnology) for the academic session 2020-21 only.

Now, therefore I, Dr. R. S. Jaipurkar, Vice-Chancellor (I/c), Sant Gadge Baba Amravati University, Amravati in exercise of powers conferred upon me under Sub-section (8) of Section 12 of the Maharashtra Public Universities Act, 2016 do hereby direct as under-

- 1) This Direction may be called, "Exemption from the entrance test for admission to M.Sc.(Biotechnology) for the academic session 2020-2021, Direction-2020."
- 2) This Direction shall come into force w.e.f. the date of its issuance.
- 3) In view of the present scenario of Covid-19 pandemic, the provisions regarding entrance test for admission to M.Sc.(Biotechnology) which are made under para 5 (b)(iii) of the Direction No. 27/2010 as well as provisions regarding entrance test in the Regulation No. 1/2020 and Rule No. 5/2005 shall not be operative for the academic session 2020-21. Hence, the students who are aspirant to seek the admission for the said course shall be exempted from the entrance test.
- 4) In this respect, the admission procedure shall be followed such as procedure follows for admissions to the other P.G. courses in the science stream.
- 5) The directives under this Direction shall be operative only for the admissions to M.Sc.(Biotechnology) exclusively and only for the academic session 2020-2021, thereafter it will be lapsed and not a part to be incorporated into the respective amending ordinance.
