Subject : Corrigendum to the Scheme of Examination of 5 Yrs. LL.B Course, which was published vide Direction No. 20 of 2009, Dt. 27.8.2009.

Whereas, Ordinance No. 5 of 2004 relating to the Examinations leading to the Degree of विधि स्नातक (Bachelor of Laws) (Five Year Degree Course) (LL.B.) (Semester Pattern) Ordinance, 2004 is in existence in the University,

AND

Whereas, the scheme of teaching and examinations prescribed under Ordinance No. 5 of 2004 was substituted by the Direction No. 20 of 2009 for LL.B. (Five Year) Degree Course Examinations,

AND

Whereas, the Direction No. 5 of 2010, relating to the Examinations leading to the Degree of विधि स्नातक (Bachelor of Laws) (Five Year Degree Course) (LL.B.) (Semester Pattern) is also in existence,

AND

Whereas, the Dean of the Faculty of Law has recommended the corrections to the Scheme of Examinations of Five Year LL.B. Course regarding the Paper :-Socio-legal Project/Research of Xth semester of 5 Years course under Direction No. 20 of 2009,

AND

Whereas, the above recommendations of the Dean of Faculty of Law has accepted by the Hon'ble Vice-Chancellor under Sub-section (7) of Section 14 of Maharashtra Universities Act, 1994 on behalf of B.O.S., Faculty of Law and Academic Council on dated 3.7.2014,

AND

Whereas, it is necessary to carry out the corrections in the scheme of examinations which was published vide above Direction immediately.

Now, therefore, I Dr. Mohan K. Khedkar, Vice Chancellor, Sant Gadge Baba Amravati University in exercise of the powers conferred upon me under sub-section (8) of section 14 of the Maharashtra Universities Act, 1994, do hereby direct as under :-

1. This Direction may be called, "Examinations leading to the Degree of विधि स्नातक (Bachelor of Laws) (Five Year Degree Course) (LL.B.) (Semester Pattern) Direction, 2014.
2. This Direction shall come into force from Summer-2014 Examination.
