Subject :- Examinations leading to the Degree of Master of Arts (बाड्मय पारंगत) in Lifelong Learning & Extension (Two years degree course, under semester pattern), Direction 2021,

Whereas, Adult, Continuing Education & Extension Services Board was constituted in the University under provision of Section 39 of then Maharashtra Universities Act-1994,

AND

Whereas, the of the said Board has been termed as the “Lifelong Learning & Extension Board” under the provision of Section 45 of the Maharashtra Universities Act-2016, which has been enforced from 1st March, 2017 in the State for all Non-Agricultural Universities,

AND

Whereas, the University has constitute the Board of Deptt. of Lifelong Learning & Extension in the University accordingly and the Board of Lifelong Learning & Extension in its meeting held on 04.03.2017 has resolved to introduce some courses in the University rendering the facility of Lifelong Learning to the public,

AND

Whereas, The Board of Lifelong Learning & Extension in its meeting held on 14.10.2016 vide item no.3 has resolved to resume the Post Graduate Degree & Diploma courses in the subject Counseling & Psychotherapy and appointed a committee for structuring the Scheme of teaching & examinations & syllabi,

AND

Where as, the Academic Council in its meeting held on 6.6.2017 vide item no. 66 has approved the draft syllabi & scheme of teaching & examinations leading to the Degree of M.A. in Lifelong Learning & Extension under the faculty of Humanities,

AND

Whereas, the Academic Council in its meeting held on 6/6/2017 Vide Item No. 39 has further resolved to assign the existing Board of Studies to the Faculty of Social Sciences which stands merged in the Faculty of Humanities and the Management Council has approved the said resolution of Academic Council in its meeting held on 20.06.2017 Vide item No. 108, under the provision of Section – 34 of M.P.U. Act 2016, read with Government of Maharashtras Vide its letter No. संकीर्ण – २०१७/प्र.क्र.२७९/विशि-३, दि. २२ जून २०१७,

AND

Whereas, the Management Council in its meeting held on 20.6.2017 vide item no. 154 has resolved to institute the said Degree course in the University under the Deptt. of Lifelong Learning & Extension, and the University has issued the Direction No.26/2017 dated 13/7/2017 o/s 12(8) of Act, Starting the said course from academic session 2017-18, Accountingly course is running,

AND

Whereas, while implementing the scheme, some discrepancies are found in the scheme of examination of III & IV semester due to which it has been difficult to prepare the programme in the system of marksheet, etc. under the existing Direction No.26/2017,

AND

Whereas, with a view to rectify the same the Vice-Chancellor, University has appointed a Committee so as to, prepare the revised Scheme of Teaching & Examination & such other provisions related to Semester - IIIrd & IVth course of M.A. in Lifelong Learning & Extension. Accordingly, the committee has revised the course contents table of Third and Fourth Semester of the main Direction para - 9 (Appx'E), and also recommended the pattern of Question paper for Semester Ist to IVth of the course,

AND

Whereas, the Vice-Chancellor has accepted and approved these recommendations of the Committee of its meeting held on 25/02/2020 under the provision of section 12(7) of Maharashtra Public Universities Act-2016, on behalf of Board of Studies, Faculty of Humanities and the Academic Council,

AND

Whereas, the Syllabi, Scheme of teaching and examinations, and provisions related to the course of Semester IIIrd & IVth and pattern of Question paper for Semester Ist to IVth of M.A. in Lifelong Learning & Extension are required to be implemented from the Academic Session 2020-21,

AND

Whereas, due to Covid – 19 pandemic, the conduct of examination since summer-20 has been affected impact of which is also experienced in admission for academic year, 2020-21 and conduct of examination of winter – 2020 which are to be conducted as yet,

AND

Whereas, the existing Direction No. 26/2017 can not be amended, and a fresh Direction needs to be issued U/S 12(8) of the Act, in view of decision of Academic Council vide item No. 4 of its meeting held on 13/1/2020, by repealing the Direction No. 26/2017,

AND

Whereas, this matter is required to be regulated by an Ordinance , and the syllabi, scheme of teaching & examinations by notification,

AND

Whereas, making an Ordinance in this respect is time consuming process,

Now, therefore, I, Dr. M.G. Chandekar, Vice-Chancellor, Sant Gadge Baba Amravati University, Amravati in exercise of powers conferred upon me under Sub-Section (8) of Section 12 of the Maharashtra Public Universities Act-2016 do hereby direct as under-

- 1) This Direction may be called “Examinations leading to the Degree of Master of Arts (वाङ्मय पारंगत) in Lifelong Learning & Extension, Direction 2021”
- 2) This Direction shall come into force from the date of its issuance, subject to specifications given in forth coming para-7 regarding its applicability.
- 3) An applicant for admission to the semester-I examination of Degree of Master of Arts in Lifelong Learning & Extension (Two year degree course), should possess at list a bachelor in any discipline of the University /other statutory University or an examination recognised as equivalent there to,
- 4) There shall be four examinations leading to the Degree of Master of Arts, namely; (which is identical as per Direction No.26/2017):
 - i) The M.A. Part-I, Semester-I & II at the end of the each Semester.
 - ii) The M.A. Part-II, Semester-III & IV at the end of each Semester.
- 5) The duration of each Semester shall be of six months. (As is already in Direction 26/2017).
- 6) The subjects under this course of study shall be comprised in the faculty of Humanities Studies
- 7) This Direction is made applicable from the batch of students admitted in the session 2019-20, in I & II Semester , and now admitted for Semester III & IV in the session 2020-21,
- 8) This course shall be conducted by the Deptt. of Lifelong Learning & Extension of the University and examinations related shall be conducted by the University.

- 9) An applicant for admission to an examination specified in paragraph 4) above must have prosecuted regular course of study prescribed for the examinations concerned, under this Direction.
- 10) Semester wise internal examination will be conducted by the department of Adult, continuing education and extension/Lifelong Learning & extension, Sant Gadge Baba Amravati University Amravati at the department level.
- 11) Semester wise University examination will be conducted by the Sant Gadge Baba Amravati University in collaboration with Examination Section as per ordinance in force.
- 12) The Scheme of teaching and examinations and syllabi for this course shall be as notified by the University by the notification in Universities Gazette Part-Two
- 13) The provision of Grace marks, condonation, etc. as per Ordinance No. 18/ 2001, shall be applicable to the students. Rules for ATKTK as those for M.A. examinations, shall apply also for this course.
- 14) The University examination shall be held as decided by the Board of Exams and Evaluations and results of examination shall be declared as per provision of the Act.
- 15) The result of examination shall be prepared and declared under SGPA in following manner:-

Where, C_i is the number of credits of the i th course and

G_i is the grade points scored by the student in the i th course.

- 16) Failure examinee may re-appear in the examination on making application with prescribed fees.
- 17) No person shall be admitted to the said course who has already passed same examination of this university or equivalent examination from other University.
- 18) Successful examinees of all Semester, shall payment of fees, shall receive the degree sign by the Vice-Chancellor, after the Convocation is held.
- 19) Existing Direction No.26/ 2017 now stands repealed.
