Subject :- Operation of Endowment Fund for institution of “जनसारस्वत सुदाम सावरकर जन्मशताब्दी स्मृतिप्रीत्यर्थ मराठी जनसाहित्य व्याख्यानमाला.”

Whereas, the endowment of Rs. 3,00,00/- is given by the donor डॉ. सुभाष सावरकर, अमरावती for institution of “जनसारस्वत सुदाम सावरकर जन्मशताब्दी स्मृतिप्रीत्यर्थ मराठी जनसाहित्य व्याख्यानमाला. ”

AND

Whereas the Management Council in its meeting held on dated 06.04.2016 vide item No. 73 has accepted the endowment.

AND

Whereas as per Statute No. 68, the matter is required to be administered by the Regulation.

AND

Whereas the Lecture Series will be arranged in near future.

AND

Whereas the meeting of Academic Council and Management Council is not scheduled in near future, and the matter is of urgent nature, and therefore the matter of making the Regulation is likely to take some time.

Now, therefore, I, Dr. M.G. Chandekar, Vice-Chancellor, Sant Gadge Baba Amravati University, Amravati, in exercise of powers conferred upon me under sub section (8) of section 12 of Chapter III of the Maharashtra Public Universities Act, 2016, hereby issue the direction as under:

1. This Direction shall be called operation of endowment fund for institution of “जनसारस्वत सुदाम सावरकर जन्मशताब्दी स्मृतिप्रीत्यर्थ मराठी जनसाहित्य व्याख्यानमाला” Direction, 2021.
2. This Direction shall come into force with effect from the date of its issuance.
3. By this Direction, the donation of Rs. 3,00,000/- donated by donor डॉ. सुभाष सावरकर, अमरावती will hereby be regulated on the following conditions:-
 - (i) The Management Council of Sant Gadge Baba Amravati University shall be the administrator of the said fund.
 - (ii) The Vice-Chancellor on recommendations of the Committee mentioned in (iii) below shall invite annually one eminent scholar to deliver two lectures on various aspects of Marathi Language, Literature Culture etc.
 - (iii) The Selection of the speaker shall be made by the Committee consisting of :-

1. The Vice-Chancellor	Chairperson
2. The Dean, Faculty of Humanities	Member
3. The Donor or his nominee	Member
4. One person nominated by the Hon.Vice-Chancellor	Member
5. Head, P.G.T.D. of Marathi	Secretary

(iv) The same Speaker will deliver two lectures, either at the University Campus or at the affiliated college within University Jurisdiction by rotation of districts mentioned below. The place of lecture shall be decided by the above committee.

(1) Amravati, (2) Akola, (3) Buldhana, (4) Yavatmal & (5) Washim.

If the districts added in the jurisdiction of the University, that will be added in the list automatically.

(v) Out of the total annual income on the endowment of rupees Three lacs, 10% shall be deducted as an administrative charges, and 25 % shall be deducted as corpus & shall be credited to the University General Fund & Main Corpus of the Endowment respectively, at the commencement of every financial year. Rs. 6,000/- shall be paid to the speaker, which will include T.A. & D.A. & Honorarium for both the lecture. Rs. 4,000/- will be utilised to meet the expenses to be incurred for holding lecture, printing of invitation cards, photographs, bouquet, dinner, tea, snacks etc. for both the lectures.

(vi) In the event of a suitable speaker not being available or for any other reason appointment is not made, no lecture series shall be held in that year.

(vii) Any money saved out of the interest of the endowment, shall be allowed to accumulate and when possible be added to the fund. The additional interest shall be utilised for increasing the value of the honorarium, to meet the expenses to be incurred for holding lectures or for other purpose as necessary.

(viii) All matters not otherwise provided in this regulation shall be determined by the Hon. Vice-Chancellor.

 - (iii) The Selection of the speaker shall be made by the Committee consisting of :-

1. The Vice-Chancellor	Chairperson
2. The Dean, faculty of Science & Technology	Member
3. The Donor or his nominee	Member
4. One person nominated by the Hon.Vice-Chancellor	Member
5. Head, P.G.T.D. of Botany	Secretary
 - (iv) The same Speaker will deliver two lectures at the Post Graduate Department of the University Campus, Sant Gadge Baba Amravati University, Amravati.

- (v) Out of the total annual income on the endowment of rupees Three lacs, 10% shall be deducted as an administrative charges, and 25 % shall be deducted as corpus & shall be credited to the University General Fund & Main Corpus of the Endowment respectively, at the commencement of every financial year. Rs. 6,000/-shall be paid to the speaker, which will include T.A. & D.A. & Honorarium for both the lectures. Rs. 4,000/- will be utilised to meet the expenses to be incurred for holding lecture, printing of invitation cards, photographs, bouquet, dinner, tea, snacks etc. for both the lectures.
- (vi) In the event of a suitable speaker not being available or for any other reason appointment is not made, no lecture series shall be held in that year.
- (vii) Any money saved out of the interest of the endowment, shall be allowed to accumulate and when possible be added to the fund. The additional interest shall be utilised for increasing the value of the honorarium, to meet the expenses to be incurred for holding lecture or for other purpose as necessary.
- (viii) All matters not otherwise provided in this regulation shall be determined by the Hon. Vice-Chancellor.
