Whereas, Ordinance No.146 relating to the Examinations leading to the Degree of वाड् मय स्नातक (Bachelor of Arts) is in existence in the University.

Whereas, the schemes of examinations for B.A.Part-II and B.A.Final are provided under the Appendices B & C respectively.

## AND

Whereas, the Academic Council in its meeting held on 17.2.2014 vide item No.22 1) A)R-1 and B) R-1 has resolved to Introduce the provision of Internal Assessment marks for the paper Compulsory Hindi of B.A.Final and Compulsory Sanskrit of B.A.II to be implemented from the Academic Session 2014-2015.

### AND

Whereas, the existing total marks 100 of the subjects Compulsory Hindi of B.A.Final and Compulsory Sankrit of B.A.Part-II are required to be changed as 70 marks for theory and 30 marks for Internal Assessment respectively.
