Whereas the Ad-hoc Committee in Environmental Studies & B.Voc Courses in its meeting dated 03/08/2021 vide Item No. 50 has recommended that all the students of B.Voc. Course shall have to complete the syllabus of the compulsory subject Environmental Studies in the 3rd Year (Semester V & VI) and they shall have to appear for the examination of the paper Environmental Studies in Semester VI and those who have aleady passed this subject, they shall be exempted from the examination of the paper Environmental Studies,
