Subject :- Examinations leading to the Degree of Master of Arts (वाङ्मय पारंगत) in Lifelong Learning & Extension (Two years degree course, under semester pattern), Direction 2022,

Whereas, Adult, Continuing Education & Extension Services Board was constituted in the University under provision of 39 of the Maharashtra Universities Act-1994,

AND

Whereas, the said Board has been termed as the Board of "Lifelong Learning & Extension" under the provision of Section 45 of the Maharashtra Public Universities Act-2016, which has been enforced from 1st March, 2017 in the State for all Non-Agricultural Universities,

AND

Whereas, the University has constituted the Board of Lifelong Learning & Extension in the University accordingly and the Board of Lifelong Learning & Extension in its meeting held on 04.03.2017 has resolved to introduce some courses in the University rendering the facility of Lifelong Learning to the Public,

AND

Whereas, The Board of Lifelong Learning & Extension in its meeting held on 14.10.2016 vide Item No. 3 has resolved to start the said course and other courses and appointed a Committee for structuring the Scheme of teaching & examinations & syllabi,

AND

Whereas, the Academic Council in its meeting held on 6.6.2017 vide Item No. 66 has approved the syllabi & scheme of teaching & examinations leading to the Degree of M.A. in Lifelong Learning & Extension under the faculty of Humanities.

AND

Whereas, the Academic Council in its meeting held on 6/6/2017 Vide Item No. 39 has further resolved to assign the existing Board of Studies to the Faculty of Social Sciences which stands merged of the Faculty of Humanities and the Management Council has approved the said resolution of Academic Council in its meeting held on 20.06.2017 Vide item No. 108, under the provision of Section 34 of the M.P.U. Act 2016, read with Government of Maharashtra Vide its letter No. संकीर्णो २०१७/प्र.क्र.२७९/-२ दिनांक २२ जुन २०१७.

AND

Whereas, The Management Council in its meeting held on 20.6.2017 vide Item No.154 has resolved to institute the said Degree course in the University under the Dept. of Lifelong Learning & Extension, and the University has issued the Direction No. 26/2017 dated 13/7/2017 u/s 12(8) of Act for the first time, starting the said course from academic session 2017-18, Accordingly the course is running, in this Department.

AND

Whereas, while implementing the scheme, some discrepancies are found in the scheme of examination of III & IV semester of M.A.in Lifelong Learning & Extension course, due to which it has been difficult to prepare the programme in the system of marksheet, etc. under the first Direction No. 26/2017.

AND

Whereas, with a view to rectify the same, the Vice-Chancellor, has appointed a Committee, so as to prepare the revised Scheme of Teaching & Examination & such other provisions related to Semester-III & IV Course of M.A. in Lifelong Learning & Extension Accordingly, the Committee has revised the course contents of Third and Fourth Semester of the first Direction Para 9 (Appx -E), and also recommended the pattern of Question papers for Semester I to IV of the course.

AND

Whereas, the Vice-Chancellor has accepted and approved these recommendations of the Committee appointed by the Board of Lifelong Learning & Extension as mention above, of its meeting held on 25/02/2020 under the provision of section 12(7) of Maharashtra Public Universities Act-2016, on behalf of Board of Studies, Faculty of Humanities and the Academic Council.

AND

Whereas, the Syllabi, Scheme of teaching and examinations, and provisions related to the course of Semester III & IV and pattern of Question paper for Semester I to IV of M.A. in Lifelong Learning & Extension have been implemented from the Academic Session 2020-21 by issuing the Direction No. 17/2021 in this regard, and the first Direction No. 26/2017 has been repealed,

AND

Whereas, the said Direction No. 17/2021 could not be converted into Ordinance hence lapsed, on completion of 6 months period U/S 12(8) of the Act, and fresh Direction needs to be issued U/S 12(8) of the Act, in view of decision of Academic Council vide item No. 4 of its meeting held on 13/1/2020.

AND

Whereas, making an Ordinance in this respect is time consuming process, and the matter is to be continued till ordinance is prescribed,

Therefore, I Dr. V. M. Bhale, Vice-Chancellor (Acting), Sant Gadge Baba Amravati University, Amravati in exercise of powers conferred upon me under sub-section (8) of Section 12 of the Maharashtra Public Universities Act-2016 do hereby direct as under-

- 1) This Direction may be called "Examinations leading to the Degree of Master of Arts (बास्मय पारंगत) in Lifelong Learning & Extension, Direction 2022"
- 2) This Direction deem to have come into force from 4th September, 2021, subject to specifications given in forth coming para-7 regarding its applicability.
- 3) An applicant for admission to the semester I examination of Degree of Master of Arts in Lifelong Learning & Extension (Two year degree course), should possess a Bachelor Degree in any discipline of the University / other statutory University or an examination recognized as equivalent there to,
- 4) There shall be four examinations leading to the Degree of Master of Arts, i.e. identical as per first Direction No. 26/2017 namely-
 - i) The M.A. Part-I, Semester-I & II at the end of the each Semester.
 - ii) The M.A. Part-II, Semester-III & IV at the end of each Semester.
- 5) The duration of each Semester shall be six months.
- 6) The subjects under this course of study shall be comprised in the faculty of Humanities.
- 7) This Direction is made applicable to the students admitted from 2021-22 academic session and onwards. However for the students already admitted in session 2020-21 and admitted in 2nd year in 2021-22 session, their III & IV semester examinations shall be conducted as per this Direction.
- 8) This course shall be conducted by the Dept. of Lifelong Learning & Extension of the University and examinations shall be conducted by the University.
- 9) An applicant for admission to an examination specified in paragraph 4) above must have prosecuted regular course of study prescribed for the examination concerned, under this Direction.
- 10) Semester wise internal examination will be conducted by the Department of Lifelong Learning and Extension, Sant Gadge Baba Amravati University Amravati at the Department Level,

- 11) Semester-wise University examination will be conducted by the Sant Gadge Baba Amravati University in collaboration with Examination section as per Ordinance in force, and all Ordinances Concerned to examinations, shall apply to the examinees.
- 12) The Scheme of teaching and examinations for this course shall be as per Annexure-I and the syllabi shall be Notified by the Notification in University Gazette Part-Two.
- 13) The provision of Grace Marks, condonation marks etc. as per Ordinance No. 18/2001, shall be applicable to the students, Rules for ATKT as those for M.A. examinations, shall apply also for this course, under Ordinance 10 for exemptions in the subjects.
- 14) The University examination shall be held as decided by the Board of Exams and Evolutions and results of examination shall be declared as per provision of the Ordinance and the Act.
- 15) Provisions of Ordinance No. 6 shall apply for publication of merit list of successful examinees, provided it shall be only for Summer examination.
- 16) The result of examination shall be for prepared and declared under SGPA in following manner:

Computation of SGPA & CGPA

$$SGPA (S_i) = \frac{\sum (C_i \times G_i)}{\sum C_i}$$

$$CGPA = \frac{\sum SGPA \times Credit}{Total Credit}$$

Where, C_i is the number of credits of the i th course and

G_i is the grade point scored by the student in the i th course.

- 17) Without prejudice to the other provisions of Ordinance No. 6 relating to examinations in General, the provisions of paragraphs 5, 8, 10, 27 and 32 of the said Ordinance shall apply to very candidate.
- 18) The provisions for improvement in Grade shall apply to the deserving candidates after passing all the four semester examinations of this course.
- 19) Examinee, every time, shall have the option of not being declared successful at the examination in case if he / she does not secure a minimum of O, A+, B+, or B Grade, which shall be irrevocable and binded for that examination.
- 20) Failure examinee may re-appear in the examination on making application with prescribed, fees as per general provisions in Ordinance etc. concerned.
- 21) No person shall be admitted to the said course that has already passed same examination of this university or equivalent examination form other University.
- 22) Successful examinees of all Semester on payment of prescribed fee for Degree certificate, shall receive the Degree under the signature of Vice- Chancellor, after the Convocation is held.
