**Subject :-** To make applicable the Manual of Procedure for Official Purchases : issued by the Industries, Energy and Labour Department of the Government of Maharashtra, Vide Resolution No. भांकस-२०१४/प्र.क्र.८२/भाग- III /उद्योग-४, दि. १ डिसेंबर, २०१६, for purchases Goods and Services by the University with referred to Section 98 of Maharashtra Public Universities Act, 2016 Direction -2022ö.

Whereas, Section 98 of Maharashtra Public Universities Act, 2016 provides the Purchase Committee for dealing with all matters pertaining to all purchases of the University in respect of such items where individual cost of each item exceeds Rs. 10 lacs at a time, and vide its sub Section (7) for not more than 10 lacs to be prescribed by the statute,

AND

Whereas, Maharashtra Public Universities Act, 2016 come into force from 1<sup>st</sup> March, 2017 in which U/sec. 71(21) provides the procedure to be followed for purchase under sub Section (7) of Section 98.

AND

Whereas, as per the Government Resolution क्रमांक युएसजी-२००९/(१६५/०९)/वि शि-२ , दि. २७ मार्च, २०१२ Common Accounts Code has been made applicable to the all Non-Agricultural Universities, by the Higher & Technical Education Department, Govt. of Maharashtra which is in existence.

AND

Whereas, the Management Council in its meeting dated 30 June, 2020, Vide Item No. 50 has accepted to follow the purchase procedure as prescribed in the Manual of Procedure for Official Purchases : issued by the Industries, Energy and Labour Department of the State Government, Vide Resolution No. भांकस-२०१४/प्र.क्र.८२/भाग- III /उद्योग-४, दि. १ डिसेंबर, २०१६,

AND

Whereas, the above mentioned Government Resolution dated 1<sup>st</sup> December, 2016 is to be adopted along with Government Resolution dated 27 March, 2012 to implement purchase procedure prescribed in this regard,

AND

Whereas, the subject matter relates to the Statute and making of which is time consuming process the Direction No. 19/2020 and No. 28/2021 were issued U/s 12(8) of the Act. The Management Council has approved the Direction No. 19/2020 vide Item No. 119 in its meeting held on 2.12.2020, and referits Draft Statute to the Statute Committee.

AND

Whereas, since then the matter is before the Statute Committee, and as per provisions of Section 12(8) of the Act, the Directon stands lapsed on completion of 6 months, if, Statute, Ordinance or Regulation, as the case may be, is not prescribed. Hence, Direction No. 28/2021 has been issued, 6 months period of which completed, hence fresh direction is to be issued to keep the provisions of earlier Directions inforce,

Therefore, I, Dr. Vilas Bhale, Vice-Chancellor of Sant Gadge Baba Amravati University, in exercise of power conferred upon me, under sub-section (8) of Section 12 of the Maharashtra Public Universities Act-2016, do hereby issue the following Direction.

- 1 This Direction may be called, To make applicable the Manual of Procedure for Official Purchases: issued by the Industries, Energy and Labour Department of the Government of Maharashtra, Vide Resolution No. भांकस-२०१४/प्र.क्र.८२/भाग- III /उद्योग-४, दि. १ डिसेंबर, २०१६, for purchases Goods Services by the University with referred to Section 98 of Maharashtra Public Universities Act, 2016 Direction 6 2022ö.
2. This Direction deem to have come into force with effect from 6<sup>th</sup> Nov., 2021, which is the next date on which earlier Direction No. 28/2021 stands lapsed,
3. Save, all the provisions laid down in Government Resolution No युएसजी-२००९/(१६५/०९)/वि शि-२, dated 27 March, 2012, as otherwise provided that the Procedure as prescribed in the Manual of Procedure for Official Purchase : issued by the Industries, Energy and Labour Department of the State Government, vide Resolution No. भांकस-२०१४/प्र.क्र.८२/भाग-III /उद्योग-४, दि. १ डिसेंबर, २०१६ and as may be amended or revised from time to time so also in future by the State Government, for all types of purchases of items and services shall be followed by the University.

On enforcement of this Direction, the provisions vide Govt. Resolution shall prevail, subject to consistency with the provision of Maharashtra Public University Act 2016, and the provision made vide former Govt. Resolution shall, to the extent to which they are repugnant to the provisions vide latter Govt. Resolution and the Maharashtra Public University Act 2016, be void.
