**Sub :- Fee for grant of affiliation and recognition to the Colleges/Institutions
by the University – Direction-2022.**

Whereas, the University has prescribed the Application Fee, Affiliation Fee, and its related fees for opening of New Colleges, Continuation of affiliation, Starting of new courses, subject, faculties etc. by issuing the Direction No. 39/2004 dated 20/01/2004 under the provisions of Section 14(8) of previously enforced Maharashtra Public Universities Act, 1994, in lieu of Ordinance No.12,

AND

Whereas, the above mentioned Act, has been superseded by Govt. of Maharashtra, and enforced the new Act as Maharashtra Public Universities Act, 2016, w.e.f. 1st March, 2017, in which u/s 73(3) it is specifically provided for prescribing fee for affiliation & Recognition by Ordinance, and in the previous Acts there was no such specific provision in Section 6 53 of making Ordinance,

AND

Whereas, in view of above, the fees are to be prescribed by prescribing a separate Ordinance for affiliation and some of the fees prescribed vide Direction 39/2004 mentioned above, are of the period more than 15 years, and medical courses with Ayurvedic medicine courses, Dental, Homeopathy, have been discontinued from the purview of the University, which needs to be revised, Therefore the Management Council vide Item No. 127 in its meeting held on 2.12.2020, considering the recommendations of Committee No. 5/2018, has revised the fees u/s 31(X) of Maharashtra Public Universities Act, 2016, to change Application Fee at Rs. 38,000/- from Rs. 10,000/- and for granting first affiliation, the fee shall be Rs. 15,000/- from 10,000/- for opening new college, and is to be implemented immediately, (col. No. 3 and 4 of Appendix 6 A of Direction No. 39/2004),

AND

Whereas, the Academic Council vide item No. 91 in its meeting held on 4.12.2020, (with reference to the resolution of Management Council vide Item No. 198 (1) dated 6.1.2020, on the resolution of Shri Vasant Ghuikhedkar, Honøble Member of Management Council,) has resolved to charge fees for continuation of affiliation (Annual affiliation fee, under Col. No. 6 of Appendix-A of Direction No. 39/2004) at Rs. 25000/- instead of Rs. 50000/- for Physical Education Colleges, which is accepted by the Honøble Vice-Chancellor u/s 12(7) of the Act on behalf of Management Council, on dated 27-05-2021 u/s 31(X) of the Act, to be implemented from ensuing session 6 2021-22,

AND

Whereas, the fees are to be prescribed u/s 73(3) of the Act, by a separate new Ordinance, process there for is time-consuming, hence the Vice-Chancellor has issued the Direction No. 32/2021 on 10.06.2021 U/s 12(8) of Maharashtra Public Universities Act, 2016,

AND

Whereas, as per Section 12(8) of Maharashtra Public Universities Act, 2016, the Direction issued under the said section, lapses after six months if no Statute, Ordinance or Regulation, as the case may be is not prescribed therefor,

AND

Whereas the making of Ordinance in above respect is under process,

Therefore, I, Dr. V.M. Bhale, Vice-Chancellor, (Acting) Sant Gadge Baba Amravati University, do hereby issue the following Direction u/s 12(8) of Maharashtra Public Universities Act, 2016.

1. This Direction may be called as "Fee for grant of affiliation and recognition to the Colleges/Institutions by the University - Direction -2022."
2. This Direction is made applicable from the academic session -2021-22.
3. The Application fee for opening new colleges, new Courses, Subjects, Faculties, increase in intake capacity, Additional Section, Natural growth etc. Courses and all other fees related to affiliation, shall be as per Appendix-A appended to this Direction.
4. The fees prescribed under this Direction shall prevail and the fees prescribed in the original Ordinance No. 12 and 20 and any Direction, which are repugnant to the fees in this Direction, stand null and void.
5. The Direction No. 39/2004 stand repealed, since Direction No. 32/2021 and hereby also by this Direction.
6. While framing a consolidate new Ordinance specifically for affiliation, the Appendix-B of fees for Permanent Affiliation, the Appendix-B of fees for Permanent Affiliation which is appended to its Direction No. 19/2021 (and further Directions to be issued subsequently to keep it in force) shall be incorporated in the consolidated new Ordinance.
