Subject :- “Amendment to Original Statute No. 68 r/w Statute No. 1 of 2012 regarding Bequests, Donations, Endowments & Transfers - Direction 2022.”

Whereas, Original Statute No. 68 as amended by Statute No. 1 of 2012 in respect of Bequests, Donations, Endowments & Transfers is in force in the University.

And

Whereas, as directed by the Management Council vide item No. 6, dated 31st January, 2017 the committee No. 1/2017 was constituted under the chairmanship of the Registrar, Sant Gadge Baba Amravati university for framing the policy regarding Bequests, Donations, Endowments & Transfers.

And

Whereas, the recommendations of the Committee No. 1/2017 for Bequests, Donations, Endowments & Transfers are accepted by the Management Council vide item No. 120 on dated 04th September, 2018.

And

Whereas, the Original Statute No. 68 r/w Statute No. 1/2012 is required to be amended for acceptance of Bequests, Donations, Endowments & Transfers.

And

Whereas, making of Statute in this respect is a time consuming process, the Vice-Chancellor has issued the Direction No. 52/2019 u/s 12 (8) of Maharashtra Public Universities Act, 2016. As per this Section of the Act, the Direction so issued, lapses after a period of six months, if the Statute, Ordinance or Regulation, as the case may be, is not prescribed therefor. As the matter of prescribing the Statute was under process, the subsequent Directions vide No. 4/2021, No. 38/2021 and No. 20/2022 have been issued u/s 12 (8) of the Act, on completion of their respective period of six months. Now the recent Direction No. 20/2022 completed its six months period and the statute is under preparation at Statute Committee's level, fresh Direction is required to be issued to continue the provisions of the earlier Directions.

Therefore, I, Dileep N. Malkhede, Vice-Chancellor, Sant Gadge Baba Amravati University in exercise of powers conferred upon me under Section 12 of sub-section (8) of the Maharashtra Public Universities Act, 2016, do hereby direct as under:

1. The Direction may be called as “Amendment to Original Statute No. 68 r/w Statute No. 1 of 2012 regarding Bequests, Donations, Endowments & Transfers - Direction 2022.”
2. This Direction shall come into force w.e.f. the date of its issuance.
3. In clause 3 of the Original Statute No.68 r/w Statute No. 1/2012 be amended as under :-
 - a) In sub clause (i) for the figure “5,00,000” the figure “7,00,000” shall be substituted.
 - b) In sub clause (ii) for figure “2,00,000” and “3,00,000” the figure “3,00,000” and “5,00,000” shall be substituted respectively.
 - c) In sub clause (iii) for the figure “1,50,000” the figure “2,00,000” shall be substituted.
 - d) In sub clause (iv) for the figure “75,000” the figure “1,00,000” shall be substituted.
 - e) In sub clause (v) for the figure “3,00,000” the figure “5,00,000” shall be substituted.
 - f) In sub clause (vi) (as inserted by Statute No. 1 of 2012) for the figure “3,00,000” the figure “5,00,000” shall be substituted.
4. The earlier Directions No. 52/2019, No. 04/2021, No. 38/2021 and recent Direction No. 20/2022 stand lapsed, after completion of their 6 months period.
