Subject :- Amendment to Regulation No. 10/2021 regarding "Procedure for approval to the promotion of Associate Professor (Academic Level -13 -A) as Professor (Academic Level -14) under Career Advancement Scheme in affiliated colleges (Aided / Unaided) Direction -2022"

Whereas, the Management Council has prescribed the Regulation No. 10/2021 on the subject cited above vide Item No. 204 from the date of its meeting held on 1st November, 2021, there after the Direction No. 5/2022 dated 13/1/2022 has been issued U/s 12(8) of Maharashtra Public Universities Act, 2016, deleting the Para (13), (14) and (15) of the said Regulation, being irrelevant as the Jt. Director of Higher education, Amravati accords sanction to the promotion under Career Advancement Scheme (CAS). By deleting these paras, the new para as “(13) अनुदानित महाविद्यालयाकडून प्रस्ताव प्राप्त झाल्याचे दिनांकापासून शक्योत्तर १ महिन्याच्या आत विद्यापीठाकडून मान्यता पत्र देण्यात येईल. विनाअनुदानित महाविद्यालयाचे प्रस्ताव प्राप्त झाल्याचे दिनांकापासून परिपूर्ण प्रस्ताव असल्यास सहयोगी प्राध्यापकाला मान्यता पत्र सदर कालावधित देण्यात येईल.” and the existing para (16) has been re-numbered as Para (14),

AND

Whereas, the said Direction No. 5/2022 is lapsed after completion of 6 months period as per Section - 12 (8) of the Act, hence fresh Direction is being issued here-with,

AND

Whereas, in addition to above, in the said Regulation No. 10/2021, the promotion under CAS to Academic Level -14 from Academic Level -13-A, to the College Library and the Physical Education teachers (teaching and not teaching both) were excluded, as the provisions there-for in the concerned 7th Pay-Commission Government Resolution dated 8th March, 2019 r/w 10 May, 2019 on UGC Regulation -2018 (Direction No, 8/2019 and 14/2019) had to be deeply gone through.,

AND

Whereas, the Senate vide Item No. 92 (118) (a) in its meeting held on 11.11.2021, has resolved to refer the above matter to the Committee which has prepared the Draft of said Regulation No. 10/2021,

AND

Whereas, the said Committee in its meeting held on 20/8/2022 has gone through the above mentioned Government Resolutions and UGC Regulation -2018 and found that Table - D and F are meant for pending cases and that Para - 7.4 (D) Provides for Library and Para 7.4 (E) for Physical Education & Sports Cadre in Colleges, in which promotion to Academic Level -14 from Level - 13 - A is permitted, both for those who are involved in teaching and who are not involve in teaching under respective provisions there-for. As Such, in view of that, Committee has recommended to include the Library/Physical education & Sports cadre in Colleges, for promotion to Level -14 from level -13-A, the words " ग्रंथपाल / शारिरिक शिक्षण व " from the Regulation No. 10/2021 need to be deleted,

AND

Whereas, the matter is related to the amendment to the Regulation No. 10/2021, Process of which takes times and the matter is to be implemented immediately, as well as the Direction No. 5/2021 is to be re-issued being lapsed after 6 months period,

Therefore, I, Dr. V.S. Chowbe, Vice Chancellor, (In-charge) Sant Gadge Baba Amravati University, do hereby, issue the Direction U/s 12 (8) of Maharashtra Public Universities Act, 2016, as under:

1. This Direction may be called "Amendment to Regulation No. 10/2021 regarding "Procedure for approval to the promotion of Associate Professor (Academic Level -13 -A) as Professor (Academic Level -14) under Career Advancement Scheme in affiliated colleges (Aided / Unaided) Direction -2022"

2. This Direction shall come in force from the date of its issuance.

3. (i) Para (13), (14) and (15) of Regulation No. 10/2021 are deleted.

(ii) consequent upon the deletion mentioned in (i) above, these paras be substituted by following:-

(a) (13) अनुदानित महाविद्यालयाकडून प्रस्ताव प्राप्त झाल्याचे दिनांकापासून शक्योत्तर १ महिन्याच्या आत विद्यापीठाकडून मान्यता पत्र देण्यात येईल. विनाअनुदानित महाविद्यालयाचे प्रस्ताव प्राप्त झाल्याचे दिनांकापासून परिपूर्ण प्रस्ताव असल्यास सहयोगी प्राध्यापकाला मान्यता पत्र सदर कालावधित देण्यात येईल.

(b) Existing Para - (16) be re-numbered as Para (14)

(iii) In the heading of the Regulation No. 10/2021 and at Sr. No. (1) the words appear in bracket "ग्रंथपाल / शारिरिक शिक्षण व " be deleted. By deleting these words from the Regulation, the provisions prescribed in this Regulation shall also be applicable to the Colleges Library and Physical Education & Sports teachers (both i.e. involving in teaching and not involving in teaching) as per provisions prescribed in the above mentioned Government Resolutions for promotion to Academic Level - 14 from Level -13 - A under Career Advancement Scheme.

However for those who opted for 6th CPC and their cases are pending under Para - 7.3 VII (b) (c), (i) & (ii) and Note thereof :-

If the cases of teachers including in Library and Physical Education & Sports, pending for placement, are resolved under this Para - 7.3 VII (b) (c) (i) (ii) & Note there-of, and there-after they fulfil the prescribed criteria, for further placement including Level -14, they shall be governed under the concerning rules of 7th Pay Commission, as per Government Resolutions Dated 8th March, 2019 and 10 May, 2019, (Direction No. 8/2019 r/w No. 14/2019).
