Sub : Filling of vacancies on the authorities, bodies or committees of the University.

Whereas sub-section (1) of section 50 of the Maharashtra Universities Act, 1994 provides-

“50(1)- When any vacancy occurs in the office of a member, other than an ex-officio member of any authority or other body of the University before the expiry of his normal term, the vacancy shall be filled, as soon as may be, by nomination of a person by the Standing Committee constituted under sub-section (2). The person so nominated shall be a person who is otherwise, eligible to be elected on the said authority or body from the same category. The person so nominated shall hold office only so long as the member in whose place he has been nominated, would have held it, if the vacancy had not occurred.”

AND

Whereas, there are vacancies occurred now in the membership of the authorities, committees or bodies of the University.

Now, therefore, in accordance with the power conferred on it by sub-section (1) of the Section 50 of the Act, the Standing Committee in its meeting held on 30th December, 2013 is pleased to nominate persons mentioned in column No.2 of the following table as Members of the Authority, Committee or Body mentioned in column No.4 under the provisions mentioned in column No.5 of the said table.
