Enhancement in the ratio of promotion quota of Class-IV cadre from 25% to 50% of total sanctioned posts in Class-III cadre for the purpose of promotion of Class-IV employees, Direction, 2016

Whereas, the Government of Maharashtra vide Government Resolution No.संकिर्ण-2010/(312/2010)/विशि-1, Dt.20th May, 2010 has cancelled the Maharashtra Non-Agricultural Universities & Affiliated Colleges Standard Code (Terms & conditions of Service of Non-Teaching Employees) Rules, 1984 and has made applicable the Maharashtra Civil Services Rules,1981 to the Non-teaching employees of the Non-Agricultural Universities in the State of Maharashtra, till such time, the common Statutes are made applicable by the State Government.

AND

Whereas, the recruitment rules for non-teaching employees of the University are not prescribed by the Maharashtra Civil Services Rules, 1981.

AND

Whereas, for time being, the recruitment rules for non-teaching employees of the University are prescribed by the Hon'ble Vice-Chancellor by issuing Direction No. 51/2010 under the powers conferred upon him u/s 14(8) of the Maharashtra Universities Act-1994.

AND

Whereas, for Class-IV cadre 25% promotion quota of total sanctioned posts of Class-III cadre is in existence under the provision of the said Direction.

AND

Whereas, the Government of Maharashtra vide its resolution No. संकिर्ण २०१५/प्र.क.५७/२०१५/विसु-१, दिनांक १४ जानेवारी, २०१६ has resolved to enhance the ratio of promotion quota for Class-IV cadre from 25% to 50% of total sanctioned posts of Class-III cadre.

AND

Whereas, the matter is to be regulated by the Common Statute which will be issued by the State Government for Non-Agriculture Universities in the State.

AND

Whereas, the Common Statute is yet to be issued by the State Government.

Now, therefore, I, Dr. V. S. Sapkal, Acting as the Vice-Chancellor of Sant Gadge Baba Amravati University, in exercise of powers conferred upon me under Sub-section (8) of Section 14 of the Maharashtra Universities Act, 1994 issue the direction as under:-

1. This Direction may be called "Enhancement in the ratio of promotion quota of Class-IV cadre from 25% to 50% of total sanctioned posts in Class-III cadre for the purpose of promotion of Class-IV employees, Direction,2016".
2. This Direction shall come into force with effect from the date of its issuance.
3. This Direction shall read with the provisions of Direction No. 51/2010.
4. the figure & sign "25%" appearing after the word "shall be" in the first line of the provision of Direction No. 51/2010 made under sub-clause (III) (b)(2)(a) of clause (3) of para 5, be substituted by the figure & sign "50%".
5. This Direction along with the Direction No. 51/2010 shall stand repealed automatically whenever the Common Statute in this respect shall be implemented by the State Government.
