**Norms for Recognition as Post-Graduate Teachers**

Whereas, the Government of Maharashtra has published Maharashtra Act No. VI of 2017 known as Maharashtra Public Universities Act, 2016;

**AND**

Whereas, the Act came into force on 1<sup>st</sup> March, 2017;

**AND**

Whereas, Sub-Section (1) of Section 36 of the Act provides the constitution of Board of Deans;

**AND**

Whereas, clause (d) of Sub-Section (1) of Section 37 of the Act, provides that the Board of Deans shall make recommendations to the Academic Council regarding the norms of recognition of Post-Graduate Teachers and Research Guides in Colleges and recognized institutions;

**AND**

Whereas, clause (e) of the Sub-Section (1) of Section 37 provides that the Board of Deans shall grant recognition to the Post-Graduate Teacher and research guides as recommended by the Research and Recognition Committee in accordance with the norms prescribed by the Academic Council;

**AND**

Whereas, original Ordinance No. 21, in respect of recognition of University and College teachers, is in existence in the University;

**AND**

Whereas, Sub-Section (6) of Section 73 of Maharashtra Public Universities Act, 2016 provides that the matter of recognition of Teachers is to be prescribed by an Ordinance;

**AND**

Whereas, to give effect to the provision of Sub-Section (e) of Section 37(1), it is necessary to make the Ordinance in this behalf;

**AND**

Whereas, making of Ordinance is a time consuming process;

**AND**

Whereas, to regulate the said matter, the Vice-Chancellor has to issue a Direction under the provisions of Sub-Section (8) of Section 12 of the Act;

**AND**

Whereas, the Vice-Chancellor has appointed a Deans Committee for recommending norms for recognition as P.G. Teacher as per the provisions of the Act;

**AND**

Whereas, the Committee has submitted its report dated 21-07-2017 recommending norms for recognition as P.G. Teacher;

**AND**

Whereas, the recommendations of the above mentioned committee has been accepted by the Vice-Chancellor on 27-07-2017 under provision of Sub-Section (7) of Section 12 of the Act on behalf of the Academic Council;

**AND**

Whereas, the main Direction No. 32/2017 was issued on 3-8-2017, read with Direction No. 3/2018, dt. 18/1/2018 on the said subject by the Hon'ble Vice-Chancellor U/s 12(8) of Maharashtra Public Universities Act, 2016 which were in existence till 2<sup>nd</sup> February, 2018, as the proviso of Section-12(8) of the Act provides that the Direction shall have to be converted into Statute, Ordinance or Regulations as the case may be, within six months of issuing of such Direction, failing which such Direction shall automatically lapse;

**AND**

Whereas, as the Maharashtra Public Universities Act, 2018, come into force recently from 1<sup>st</sup> March, 2017 thereby the authorities, including Board of Deans, Academic Council, Management Council, etc. are under process of constitution, hence meeting of Academic Council could not be convened to get approved the Directions and Draft Ordinance therefor;

**AND**

Whereas, the main Direction No. 32/2017 with amendment Direction No. 3/2018 are automatically lapsed from 3<sup>rd</sup> February, 2018 due to reasons mentioned in foregoing para, by completing six months period;

**AND**

Whereas, the said matter is to be continued further, till Ordinance therefor is prescribed by preparing it by Board of Deans considering and approving the Direction & Draft Ordinance by the Academic Council, and approved by the Management Council, as provided in Maharashtra Public Universities Act, 2016;

Therefore, I, Murlidhar Chandekar, Vice-Chancellor, Sant Gadge Baba Amravati University in exercise of the powers conferred on me, vide Sub-Section (8) of Section 12 of the Maharashtra Public Universities Act, 2016 do hereby issue the following Directions-

1. This Direction may be called, "Norms for Recognition as Post-Graduate Teachers, 2018".
2. This Direction shall come into force from 3<sup>rd</sup> February, 2018.

3. In this Direction, unless the context otherwise requires-
- a) "Act" means Maharashtra Public Universities Act, 2016 i.e. Maharashtra Act No. VI of 2017.
  - b) "Academic Council" means the Council constituted under sub-Section (1) of Section 32 of the Act.
  - c) "Board of Deans" means the Board constituted under sub-Section (1)(2) of Section 36 of the Act.
  - d) "College" means the College affiliated to the Universities situated in the University area or jurisdiction.
  - e) "Post-Graduate Department" means a Department in the college or institution of Higher learning, research or specialized studies, recognized to be so, by the university and imparting Post-Graduate instruction or guidance for research.
  - f) "Recognized Institution" means an Institution of higher learning, research or specialized studies, other than college, and recognized to be so, by the University.
  - g) "Research and Recognition Committee" means the committee for each Board of Studies constituted under provision of sub-Section (2) of Section 37 of the Act.
  - h) "Teacher" means full time approved Professor, Associate Professor, Assistant Professor, Reader, Lecturer, Librarian, Principal, Director of an Institution, Director of Knowledge Resource Centre, Director of Centre of Lifelong Learning and Extension, Deputy/ Assistant Librarian in the University, College Librarian, Director or Instructor of Physical Education in any University Department, conducted, affiliated or autonomous college, autonomous institution or department or recognized institution of the University;
4. Norms for Recognition as P.G. Teacher will be as follows:-

- 1) A full time teacher approved by the University having ten years teaching experience at graduate level and Ph.D. in relevant subject.
  - 2) Post-Graduate teaching experience certified by the Competent Authority.
  - 3) Three publications at national/international level having ISSN/ISBN number.

- A Ph.D. supervisor recognized by the University in relevant subject having registered atleast two students for Ph.D.
