Subject:- Direction amending main Ordinance No. 16/2007 of providing photocopy of answerbooks, redressal mechanism and Direction NO. 66/2010 for re-assessment without obtaining photocopy of answerbooks Direction-2016 read with Direction No. 24/2015.

Whereas, the Academic Council in its meeting held on 6th May 2015 vide Item no. 43 has accepted the recommendations of Board of Examinations, and also accepted the recommendation of Board of Examinations held on 21/8/2015 vide item no.1 'confirmation of minutes about information no.3' u/s 14(7) dated10/12/2015. Hence the Direction no. 24 of 2015 has been issued under sub section (8) of Section 14 of Maharashtra Universities Act, 1994.

And whereas, the above facility is executed to the examinees, and the Board of Examinations vide Item No.1 of its meeting held on 25/04/2016 has corrected the minute 'about information no.3'of Board of Examinations meeting dated 21/08/2015 as under, regarding Redressal/Reassessment of answerbooks:- " चर्चेच्या अनुषंगाने,परिक्षा मंडळाने असे निर्देश दिले की, पुनर्मूल्यांकनाचा निकाल उशिरा जाहीर होत असल्यास त्या दरम्यान सदर विद्यार्थ्याने त्याच विषयाची परीक्षा दिली असेल तर अशा वेळी पुन्हा दिलेल्या परीक्षेत मिळालेले गुण व पुनर्मूल्यांकनामध्ये प्राप्त झालेले गुण यामधील जे गुण जास्त असतील, ते विद्यार्थ्याला प्रदान करण्यात यावे "

And whereas the Board of Examinations in its meeting held on 21/07/2016 vide Item No. 19 has taken the following decisions regarding redressal/re-assessment of answerbooks under Examination Management System:-

- "(i) The period to apply for obtaining the softcopy of valued answerbook shall be 10 days.
- (ii) The period of providing softcopy of valued answerbook shall be 20 days.
- (iii) The period of declaring result of reassessment without obtaining softcopy of valued answerbooks shall be 45 days.
- (iv) An examinee can demand softcopy of valued answerbooks for all subjects instead of only two theory papers, but he/she will be allowed to apply for reassessment of only two papers."

And whereas, the above recommendations of Board of Examinations is approved u/s 14(7) of the Maharashtra Universitties Act, 1994 by the Hon'ble Vice-Chancellor on behalf of Academic Council and Management Council.

And whereas, the matter is to be regulated by making ordinance, which may take time,

- I, therefore, Dr. Murlidhar Chandekar, Vice-Chancellor, Sant Gadge Baba Amravati University, Amravati in exercise of powers conferred upon me u/s 14(8) of Maharashtra Universities Act, 1994, hereby issue the Direction as under :-
- (1) This Direction may be called "Direction amending main Ordinance No. 16/2007 of providing photocopy of answerbooks, redressal mechanism and Direction NO. 66/2010 for re-assessment without obtaining photocopy of answerbooks Direction-2016 read with Direction No. 24/2015"
- (2) This Direction shall come into force from the date of its issuance.

- (3) (i) The first three paras on Page No. 187 of the Direction No.24/2015 be deleted.
 - (ii) Serial no. 4. of Direction No. 24 of 2015 is hereby deleted, and original provision of para no. 18 of Ordinance no. 16 of 2007 and para no. 12 of Direction no. 66 of 2010 is now being kept intact and hereby prevail as were enforce prior to enforcement of the Direction No. 24/2015 to this extent.
 - (iii) The Sr. No. (5) of the Direction No. 24 of 2015 regarding enclosing of marksheet is hereby deleted.
 - (iv) A new proviso, in para- 21 of Ordinance No. 16/2007 and in para-15 of Direction No. 66 of 2010, be added as under :-

"Provided further that if the examinee has appeared in succeeding examination in the subject/s or paper/s in which he/she has applied for Redressal or Re-assessment and the result of Redressal or Re-assessment is declared later-on, the examinee shall be awarded the higher marks scored by him/her either in Redressal/Re-assessment or in succeeding examination"

(4) At the end of Ordinance No. 16/2007 and Direction NO. 66/2010, the following matter be added :-

Providing Soft copies of Answerbooks on-line Redressal and Re-assessment of Answerbook/s under Examination Management System in the Faculties of (1) Medicine (Pharmacy) (2) Law and (3) Engg. and Technology and examinations in other faculties to be added from time to time.

- (i) The period to apply for obtaining the softcopy of valued answerbook shall be 10 days
- (ii) The period of providing softcopy of valued answerbook shall be 20 days.
- (iii) The period of declaring result of reassessment without obtaining softcopy of valued answerbooks shall be 45 days.
- (iv) An examinee can demand softcopy of valued answerbooks for all subjects instead of only two theory papers, but he/she will be allowed to apply for reassessment of only two papers.
- (5) The provisions under para (3) (i) to (iv) of this Direction as mentioned above shall also apply to the Examinations under Examination Management System mention in para (4) above.
