Subject:- Continuation to the issuance effect of direction No. 32/2018 which was in the respect of Facilities, exemption and concession for differently abled and Physically disabled examinee of Sant Gadge Baba Amravati University examinations.

Whereas, "Maharashtra Public University Act, 2016" has been implemented for Non-Agricultural Universities in the State.

And

Whereas the Higher and Technical Education Department of Maharashtra, has been directed to implement the said Act with effect from 1 March, 2017.

And

Whereas, for the time being, Vice-Chancellor have power to regulate the matter by issuing direction under the provision of Sub-section (8) of Section 12 of Maharashtra Public University Act-2016.

And

Whereas, Making of Ordinance regarding Facilities, exemption and concession for differently abled and Physically disabled examinee of Sant Gadge Baba Amravati University examinations is time consuming process, the Hon'ble Vice-Chancellor has issued direction 32/2018 for providing Facilities, Examinations & Concession to Physically abled examinations of the University.

And

Whereas, the provisio of sub-section (8) of Section 12 of the Maharashtra Public Universities Act-2016 provides that such directions to be converted into related statutory forms within six months and failing which such directions shall be automatically lapsed.

And

Whereas, in view of non conversion of Direction into Ordinance due to process & formation of concern authority, it is necessary to continue the issuance effect of Direction No. 32/2018 which was issued in the respect of Facilities, exemption and concession for differently abled and Physically disabled examinee of Sant Gadge Baba Amravati University examinations for avoiding the administrative complications.

Now, therefore I, Dr. Murlidhar Chandekar, Vice-Chancellor, Sant Gadge Baba Amravati University, Amravati in exercise of powers conferred upon me under Sub-section (8) of Section 12 of the Maharashtra Public Universities Act-2016 having issued the following directions;

- 1) This Direction may be called, "Continuation to the issuance effect of Direction No. 32/2018 of Facilities, exemption and concession for differently abled and Physically disabled examinee of Sant Gadge Baba Amravati University examinations."
- 2) This Direction shall come in force with effect from the date of it's issuance.
- 3) The issuance effect of the Direction No. 32/2018 which was issued in respect of Facilities, exemption and concession for differently abled and Physically disabled examinee of Sant Gadge Baba Amravati University examinations shall be continued.
