Sub.:- Norms for Recognition as Post-Graduate Teachers - Direction 2019

Ref. :- 1. Direction No. 32/2017 (r/w amended Direction

No. 3/2018), dt. 03-08-2017 & dt. 18-01-2018.

3. Direction No. 36/2018, dt. 13-09-2018.

Whereas, clause (d) of Sub-Section (1) of Section 37 of the Act, provides that the Board of Deans shall make recommendations to the Academic Council regarding the norms of recognition of Post-Graduate Teachers and Research Guides in Colleges and recognized institutions;

AND

Whereas, clause (e) of the Sub-Section (1) of Section 37 provides that the Board of Deans shall grant recognition to the Post-Graduate Teachers and research guides as recommended by the Research and Recognition Committee in accordance with the norms prescribed by the Academic Council;

AND

Whereas, Original Ordinance No. 21, in respect of recognition of University and College teachers, is in existence in the University;

AND

Whereas, Sub-Section (6) of Section 73 of Maharashtra Public Universities Act, 2016 provides that, the matter of recognition of Teachers is to be prescribed by an Ordinance;

AND

Whereas, to give effect to the provision of clause (e) of Sub-Section (1) of Section-37, it is necessary to make the Ordinance in this behalf;

AND

Whereas, making of Ordinance is a time consuming process;

AND

Whereas, the Vice-Chancellor had appointed a Deans Committee for recommending norms for recognition as P.G. Teachers as per the provisions of the Act which had submitted its recommendations dated 21-07-2017 recommending norms for recognition as P.G. Teachers;

AND

Whereas, the recommendations of the above mentioned Committee had been accepted by the Vice-Chancellor on 27-07-2017 under provision of Sub-Section (7) of Section 12 of the Act on behalf of the Academic Council and had issued the Directions u/s 12(8) of the Act as referred above,

AND

Whereas, the Academic Council vide Item No. 03 in the meeting held on 15-11-2018 has approved the action taken U/s12(7) of the Act and these Directions under reference have also been approved by the Academic Council vide Item No. 28 in the same meeting, and resolved to refer the Draft Ordinance to the Board of Deans;

AND

Whereas, the Draft Ordinance is under process of placing before the Board of Deans, and further process is time-consuming,

AND

Whereas, Section-12(8) of the Act provides that the Direction shall have to be converted into Statute, Ordinance or Regulations as the case may be, within six months of issuing of such Direction, failing which such Direction shall automatically lapse, and in view of this the Direction No. 36/2018 referred to above, is going to lapse w.e.f. 13-03-2019.

Therefore, I, Dr. Murlidhar Chandekar, Vice-Chancellor, Sant Gadge Baba Amravati University in exercise of the powers conferred on me, vide Sub-Section (8) of Section 12 of the Maharashtra Public Universities Act, 2016 do hereby issue the following Directions-

- 1. This Direction may be called, "Norms for Recognition as Post-Graduate Teachers Direction 2019".
- 2. This Direction shall come into force from the date of its issuance, for the matters contained in the Directions under reference, which are reproduced in the following Paras -3, 4 and 5.
- 3. In this Direction, unless the context otherwise requires
 - a) "Act" means Maharashtra Public Universities Act, 2016 i.e. Maharashtra Act No. VI of 2017.
 - b) "Academic Council" means the Council constituted under sub-Section (1) of Section 32 of the Act.
 - c) "Board of Deans" means the Board constituted under sub-Section (1)(2) of Section 36 of the Act.
 - d) "College" means the College affiliated to the Universities situated in the University area or jurisdiction.
 - e) "Post-Graduate Department" means a Department in the college or institution of Higher learning, research or specialized studies, recognized to be so, by the university and imparting Post-Graduate instruction or guidance for research.
 - f) "Recognized Institution" means an Institution of higher learning, research or specialized studies, other than college, and recognized to be so, by the University.
 - g) "Research and Recognition Committee" means the committee for each Board of Studies constituted under provision of sub-Section (2) of Section 37 of the Act.
 - h) "Teacher" means full time approved Professor, Associate Professor, Assistant Professor, Reader, Lecturer, Librarian, Principal, Director of an Institution, Director of Knowledge Resource Centre, Director of Centre of Lifelong Learning and Extension, Deputy/ Assistant Librarian in the University, College Librarian, Director or Instructor of Physical Education in any University Department, conducted, affiliated or autonomous college, autonomous institution or department or recognized institution of the University;
 - 4. Norms for Recognition as P.G. Teacher will be as follows:-

(A)

- 1) A full time teacher approved by the University having ten years teaching experience at graduate level and Ph.D. in relevant subject.
- 2) Post-Graduate teaching experience certified by the Competent Authority.
- 3) Three publications at national/international level having ISSN/ISBN number.

<u>OR</u>

(B)

A Ph.D. supervisor recognized by the University in relevant subject having registered atleast two students for Ph.D.
