Subject :- Discontinuation of decentralisation of University Examinations of Various Courses.

Whereas, the Academic Council in its meeting held on dated 6.6.2017 vide Item No. 57, resolved to decentralize the University examinations excluding post graduate examination;

AND

Whereas, the Management Council in its meeting held on 30.6.2017 vide item no. 139 upheld the decision of academic Council regarding decentralisation of University Examinations;

AND

Whereas, the Hon'ble Vice Chancellor has issued the direction No. 40/2017 dated 26/9/2017 for implementing the process for conduction of examinations as per decision of Academic Council;

AND

Whereas, the recommendations of the Committee constituted by Hon'ble Vice Chancellor as per decision of Academic Council on 6/6/2017 vide item No. 57 were approved by the Hon'ble Vice Chancellor on behalf of the Academic Council under section 12(7) of Maharashtra Public Universities Act,2016 and issued Direction No. 24/2018 regarding to repeal Direction No. 40/2017.

AND

Whereas, in view of non-conversion of Direction No. 24/2018 into Ordinance within prescribed time limit by the concerned authority, the Direction No. 38/2018 was issued for giving continuation effect to the Direction No. 24/2018.

AND

Whereas, Academic Council dated 15/11/2018 vide item No. 43 resolved that University examinations shall be conducted by the University as per previous procedures from Summer 2019 examinations;

AND

Whereas, in view of the above decision of the Academic Council, the Hon'ble Vice Chancellor has constituted a Committee for examining the effect of the decision of on repealing the Direction No.24 of 2018 ;

AND

Whereas, Academic Council in its meeting dated 6/6/2017 vide Item No. 40 resolved as under :-

“विद्यापीठ अनुदान आयोगाच्या अंतर्गत येत असलेल्या व ज्या अभ्यासक्रमांच्या काही परीक्षा महाविद्यालय स्तरावर घेण्यात येतील त्या अभ्यासक्रमांचा **Cumulative Grade Point Average (CGPA)** हा त्याकरिता परीक्षा व मुल्यमापन मंडळाने विहित केलेल्या तरतुदीप्रमाणे तसेच उर्वरित अभ्यासक्रमांचा **Cumulative Grade Point Average (CGPA)** हा विद्या परिषदेने मान्य केल्याप्रमाणे राहिल.”;

AND

Whereas, the Academic Council on 28/4/2017 vide item No. 36 regarding UGC Guidelines for CGPA resolved to refer the letter to faculties for consideration and onwards recommendations of faculties;

AND

Whereas, various faculties recommend from time to time computation of CGPA for various courses to the Academic Council;

AND

Whereas, the Academic Council in its meeting dated 6/6/2017 vide of Item No. 43, while considering the recommendations of the Faculties, resolved as under...

“(A) (1) The Computation of C.G.P.A. and the Scheme of teaching & examination will be as given by apex bodies of the respective courses or as prescribed by the University.”;

Now therefore I, Dr. Murlidhar Chandekar. Vice Chancellor, Sant Gadge Baba Amravati University, Amravati in exercise of powers conferred upon me under sub-section (8) of Section 12 of the Maharashtra Public Universities Act, 2016 do hereby direct as under:-

1. This Direction may be called, “Discontinuation of decentralisation of University Examinations of Various Courses, 2019”.
2. This Direction shall come in force with effect from the Summer, 2019 examinations and onwards.
3. The conduction of examinations by the colleges as per decision regarding decentralisation of examinations and declarations of results thereof from Summer-2019 and all university examinations shall be as per Directions, Ordinances and other legislations/orders which were published prior to Direction No.24/2018.
4. Where computation of the CGPA of courses are not mentioned, the CGPA of the courses shall be as prescribed by the apex bodies such as UGC, AICTE etc. of the courses.
5. The Direction No. 24/2018 dated 27/3/2018 regarding decentralisation of University Examinations of various courses.
