Corrigendum to Direction No. 5/2019, dated 1.2.2019 regarding required undertakings, certificates and supportive evidences to be submitted by proposer/ candidate at the time of filling Nomination Papers for election/nomination/co-option by members during meeting of the Board of Studies.

Whereas, the Government of Maharashtra in Higher and Technical Education Department, Mantralaya, Mumbai, vide Notification No.MNS-2016/(347/16)/Ue-3, dated 28th April, 2017 has specified the eligibility conditions for being elected or nominated or co-opted as a member of the authorities of the University.

AND

Whereas, procedure for election, nomination and co-option of members by the Board of Studies in the first meeting of Board of Studies is prescribed by various directions,

AND

Whereas, taking into consideration the eligibility conditions prescribed by the Government vide Notification No.MNS-2016/(347/16)/Ue-3, dated 28th April, 2017 regarding eligibility conditions for being elected or nominated or co-opted as a member of Authority(ies)/Committee(s) of the University,

AND

Whereas, undertakings, certificates and supportive evidences for fulfilling the essential conditions/qualifications for a person to be elected, nominated and co-opted are necessary for varification,

AND

Whereas, Direction No. 5/2019, dated 1.2.2019 was issued for required undertakings, certificates and supportive evidences to be submitted by proposer/ candidate at the time of filling Nomination Papers for election/nomination/cooption by members during meeting of the Board of Studies,

AND

Whereas, Para 5. iii) of Direction No. 5/2019 provides to submit the Certificate of University/ Principal for P.G.recognised teachers imparting teaching to P.G. Students,

AND

Whereas, it is construed that the separate certificate for P.G. recognised teacher to be sought from University and certificate for imparting teaching to P.G. Students to be sought from the Principal of concerned college in view of provision 40 (2)(d)(i) of Maharashtra Public Universities Act, 2016,

AND

Whereas, it is imperative to make changes in this Direction in terms of submitting certificates (Certificates of the University and Certificate of the Principal) regarding P.G. recognised teachers imparting teaching to P.G. Students,

AND

Whereas, the matter is required to be regulated by the Statute and framing of Statute may take some time, hence the Direction is required to be issued.

Now, therefore, I, Dr.M.G.Chandekar, Vice Chancellor of Sant Gadge Baba Amravati University, in exercise of powers conferred upon me under sub-section (8) of section 12 of the Maharashtra Public Universities Act, 2016, do hereby direct as under:

- 1. This Direction may be called õCorrigendum to Direction No. 5/2019, dated 1.2.2019 regarding required undertakings, certificates and supportive evidences to be submitted by the proposer/ candidate at the time of filling Nomination Paper for election, nomination and co-option of members by Board of Studies, Direction 2019.ö
- 2. This Direction shall come into force from the date of its issuance.
