Ordinance No. 1 of 2019

Recognition of University and College Teachers (Amendment) Ordinance, 2019

Whereas, it is expedient to amend the Ordinance No. 21 regarding Recognition of University and College Teachers hereinafter referred to as Original Ordinance No. 21, for the purpose hereinafter appearing, the Management Council hereby pleased to make the following ordinance.

1. This Ordinance may be called , Recognition of University and College Teachers (Amendment) Ordinance, 2019.
2. This Ordinance shall come into force with effect from the date of its approval by the Management Council.
3. In this Ordinance, unless the context otherwise requires-
 - 3.1 (a) "Academic Council" means the Council constituted under sub-section (1) of section 32 of the Act.
 - (b) "Act" means Maharashtra Public Universities Act, 2016 i.e. Maharashtra Act No. VI of 2017.
 - (c) "Board of Deans" means the Board constituted under sub-Section (1) (2) of section 36 of the Act.
 - (d) "College" means the College affiliated to the University situated in the University area or jurisdiction.
 - (e) "ISBN" means International Standard Book No.
 - (f) "ISSN" means International Standard Serial No.
 - (g) "Post-Graduate Department" means a department in a college or institution of higher learning, research or specialized studies, recognized to be so, by the university and imparting post-graduate instruction or guidance for research.
 - (h) "Ph.D. supervisor" means a teacher recognized as a Ph.D. supervisor by the university.
 - (i) "P.G. Programme" means the programmes imparting instructions at post graduate level in various faculties and for the guidance of research studies or specialized studies in the university teaching departments/recognized institutions/affiliated colleges/post graduate centre.
 - (j) "Recognized Institution" means an institution of higher learning, research or specialized studies, other than a college, and recognized to be so, by the university.
 - (k) "Research and Recognition Committee" means the committee for each Board of Studies constituted under provision of sub-Section (2) of section 37 of the Act.

- (l) "Teacher" means full time approved professor, associate professor, assistant professor, reader, lecturer, librarian, principal, Director of an Institution, Director of Knowledge Resource Centre, Director of Centre of Lifelong Learning and Extension, deputy/assistant Librarian in the university, college librarian, Director or instructor of physical education in any university department, conducted, affiliated or autonomous college, autonomous institution or department or recognized institution of the University;
- 3.2 At the end of Ordinance No. 21 (hereinafter referred to as the main Ordinance) after the existing proforma Appendix appears below last para-7, the following new para-8.(a) and (b) be added-
4. Norms of Recognition of Post Graduate Teacher will be as follows:-
- 8(a) : Notwithstanding anything contained to the contrary to the extent of criteria for Recognition of Post Graduate Teachers in fore-going paras of this Ordinance, the following shall be the norms for recognition of Post Graduate Teachers.

- 1) A full time teacher approved by the university having ten years teaching experience at graduate level and Ph.D. in relevant subject.
 - 2) Post-graduate teaching experience certified by the competent authority.
 - 3) Three publications at national/international level having ISSN/ISBN number.

- A Ph.D. supervisor recognized by the university in relevant subject having registered atleast two students for Ph.D.
- (a) The proforma specifically for submitting the information by the applicant seeking recognition as Post Graduate Teacher is appended to this Ordinance.
