Whereas, Direction Nos. 11 of 2017 & 16 of 2018 in respect of the Schemes of teaching & examination of III to VIII Semesters of B.E. (Electronics & Telecommunications Engg.) as per C.G.S. in the Faculty of Science & Technology are in existence,

AND

Whereas, the Chairperson, B.O.S. in Electronics, Industrial Electronics & Applied Electronics and two members vide letter on 23/10/2019 and the consent given by other members of the B.O.S. vide their e-mail regarding suggesting corrections / changes in the Title of the syllabus of the subject 8ET3 -Data Communication Networkø in the Scheme of teaching & examination of Semester VIII of B.E. (Electronics & Telecommunications Engg.) published vide Direction No. 11/2017 dtd.28/6/2017 to be implemented from the academic session 2019-2020 & onwards,

AND

Whereas, the Honøble Vice-Chancellor has accepted and accorded approval to the request made by the Chairperson & the consent received by e-mail from other members of the Board of Studies in Electronics, Ind. Electronics & App. Electronics in the Faculty of Science & Technology vide letter received on 23/10/2019 regarding suggesting changes in the Title of the syllabi of the subject 8ET3 Data Communication Network of Sem. VIII of B.E. (Electronics & Telecommunication Engg.) under u/s 12 (7) of the Maharashtra Public Universities Act, 2016 on behalf of the Board of Studies, Faculty of Science & Technology and Academic Council to be implemented from the academic session 2019-2020 & onwards,

AND

Whereas, changes in the title of the scheme of teaching & examinations of Semester VIII of B.E. (Electronics & Telecommunications Engg.) as per C.G.S. are to be implemented from the academic session 2019-2020 & onwards,

AND

Whereas, the schemes of teaching & examinations of Semesters III to VIII of B.E. (Electronics & Telecommunications Engg.) are required to be regulated by an Ordinance/ Regulation,

AND

Whereas, the process of making an Ordinance / Regulation is a time consuming process,

Now, therefore, I, Dr. M.G. Chandekar. Vice-Chancellor of Sant Gadge Baba Amravati University, Amravati in exercise of powers conferred upon me under the sub-section (8) of Section 12 of the Maharashtra Public Universities Act, 2016, do hereby direct as under:-

- (i) This Direction shall be called õCorrigendum to Direction No. 11 of 2017 in respect of the Schemes of teaching & examination of Semester III to VIII of B.E. (Electronics & Telecommunication Engg.) as per C.G.S. in the Faculty of Science & Technologyö.
- (ii) The Direction shall come into force from the date of its issuance.
- (iii) The Title in Direction No. 11 of 2017 of the subject 8ET3 õData Communication Networkö of Sem. VIII of B.E. (Electronics & Telecommunications Engg.) in the revised Schemes of teaching and examination of Semesters III to VIII of B.E. (Electronics & Telecommunications Engg.) as per C.G.S. in the Faculty of Science & Technology shall be substituted by the Title õCommunication Networksö.

Subject: Continuation to the issuance effect of Direction No. 11 of 2019 which was issued in respect of the Examinations leading to the Certificate/ Diploma/Advanced Diploma/ Degree in various subjects of Bachelor of Vocation (B.Voc.) degree Course in the Faculty of Inter-disciplinary Studies, Direction, 2019.

Whereas, õMaharashtra Public Universities Act, 2016ö has come into force from 1st of March, 2017,

AND

Whereas, Sant Gadge Baba Amravati University (hereinafter õthe Universityö) is now being governed by the Maharashtra Public Universities Act, 2016 (VI of 2017) (hereinafter #the Actø),

AND

Whereas, the resolutions made by the authorities concerned from time to time, there was an exigency to amend the Ordinance/Regulation in respect of the examiations leading to the Certificate/ Diploma/Advanced Diploma/ Degree in various subjects of Bachelor of Vocation (B.Voc.) degree Course in the Faculty of Inter-disciplinary Studies and making and amending the respective Ordinance/Regulation was time consuming process, the Honøble Vice-Chancellor had issued Direction No. 11 of 2019 ,

AND

Whereas, the proviso of sub-section (8) of Section 12 of the Maharashtra Public Universities Act, 2016 provides that such directions are to be converted into related statutory forms within six months and failing which such directions shall be automatically lapsed,

AND

Whereas, in view of the exceptional circumstances arises, it is necessary to continue the issuance effect of directions no. 11 of 2019, which was issued in respect of the Examiations leading to the Certificate/Diploma/Advanced Diploma/ Degree in various subjects of Bachelor of Vocation (B.Voc.) degree Course in the Faculty of Inter-disciplinary Studies.

Now, therefore, I, Dr. M. G. Chandekar, Vice-Chancellor of Sant Gadge Baba Amravati University, in exercise of powers conferred upon me, under sub-section (8) of Section 12 of the Maharashtra Public Universities Act, 2016, do hereby direct as under:

- 1. This Direction may be called, "Continuation to the issuance effect of Direction No. 11 of 2019 which was issued in respect of the Examiations leading to the Certificate/ Diploma/Advanced Diploma/ Degree in various subjects of Bachelor of Vocation (B.Voc.) degree Course in the Faculty of Inter-disciplinary Studies, Direction, 2019ö.
- 2. This direction shall come into force with effect from the date of its issuance.
