

Regulation No. 6 of 2015.

**Operation of endowment fund for awarding Late Dilip B. Shingore
Scholarship (Amendment) Regulation, 2015.**

Whereas it is expedient to amend the Regulation No. 33 of 2007 in respect of Operation of endowment fund for awarding Late Dilip B. Shingore Scholarship i.e. Original Regulation for the purpose hereinafter appearing, the Academic Council is hereby pleased to make the following Regulation.

1. This Regulation may be called “Operation of endowment fund for awarding Late Dilip B. Shingore Scholarship (Amendment) Regulation, 2015.”
2. This Regulation shall come into force w.e.f. the date of its approval by the Management Council.
3. **In Clause 3**
In the second line after the word “Amravati” the words & figures “and by adding balance additional interest of Rs. 15,000/- the total endowment becomes of Rs. 30,000/-” be added.
4. **In Clause 3 (i)**
The words, figures & sign “1,500/- (Rs. One Thousand Five Hundred” be substituted by the words, figures & sign “2,000/- (Rs. Two Thousand”.
5. **In Clause 3 (iv)**
In the third line after the word “B.E.” the words & sign “(Electrical Engineering)” be substituted by the words & sign “(All courses of Electrical Engineering Branch)” and in the fifth line after the word “B.E.” the words & sign “(Electrical Engineering)” be substituted by the words & sign “(All courses of Electrical Engineering Branch)”. At the end of the para the sentence “If, in future any course will be added in the Electrical Engineering Branch, the selection of the student will be made from amongst all the courses of Electrical Engineering Branch in the faculty of Engineering & Technology of the University.” be added.
6. **In Clause 3 (v)**
After the word “year” the words & sign “payable in 3 instalment in the month of August, November, February.” be deleted.

Regulation No. 7 of 2015.

Operation of endowment fund for organizing Dr. Motilal Rathi Workshop on Public Awareness about Public Health (Amendment) Regulation, 2015.

Whereas it is expedient to amend the Regulation No. 11 of 2004 in respect of Operation of endowment fund for organizing Dr. Motilal Rathi Workshop on Public Awareness about Public Health i.e. Original Regulation for the purpose hereinafter appearing, the Academic Council is hereby pleased to make the following Regulation.

7. This Regulation may be called “Operation of endowment fund for organizing Dr. Motilal Rathi Workshop on Public Awareness about Public Health (Amendment) Regulation, 2015.”
8. This Regulation shall come into force w.e.f. the date of its approval by the Management Council.

9. In Clause 3

In the second line after the word “Amravati” the words & figures “and by adding balance additional interest of Rs. 1,00,000/- the total endowment becomes of Rs. 2,00,000/-” be added.

In Clause 3 (viii)

In the first line the words, figures & sign “By expecting the interest at a minimum of 6% on investment of endowment, out” be substituted by the word “Out” and in fifth line the figure “3,500/-” be substituted by the figure “10,000/-” and in second para – in second line the words, figures & sign “than 6%” be deleted and the figure “3,500/-” be substituted by the figure “10,000/-”.
