# Sub:-National Council for Teachers Education (Recognition norms and procedure) Regulations-2014 & amended by Regulation -2017 and Govt. Resolution No.B.Ed. -४६१५/प्र.क्र.२०८(१)/म.शि.-२, dt. 03.12.2018: Direction -2020

Whereas, the National Council for Teachers Education (NCTE) has issued the Notification No. F 51-1/2014 – NCTE (N&S) on 28<sup>th</sup> Nov. 2014 as NCTE (Recognition norms & procedure) Regulations -2014 in suppression of NCTE Regulations-2009, and amended vide Regulations-2017 vide Notification No. F 51-1/2015 – NCTE (N&S) dated 29<sup>th</sup> May, 2017.

## AND

Whereas, subsequently, the Government of Maharashtra, Higher & Technical Education Department, has issued the Government Resolution No. B.Ed. - ४६१५/प्र.क्र.२०८(१)/ म.शि.-२, dt. 03.December, 2018 in reference to above,

### AND

Whereas, the Section -71(20) of Maharashtra Public Universities Act, 2016 provides that, qualifications service conditions assessment, etc. of teachers, officers, employees of the University and affiliated colleges, shall be as approved by the State Government.

## **AND**

Whereas, the matter is of statutory nature which is to be prescribed in the form of Statute as prescribed in Statute No. 1 of 1979 and the framing thereof u/s 72 of the Act, is time –taking process,

Therefore, I, Dr. Murlidhar Chandekar Vice-Chancellor, Sant Gadge Baba Amravati University, in exercise of powers vested in me vide Sub-section (8) of Section -12 of Maharashtra Public Universities Act 2016, hereby issue the following Direction:

- 1. This Direction may be called "National Council for Teachers Education (Recognition norms and procedure) Regulations-2014 & amended by Regulation -2017 and Govt. Resolution No. B.Ed. -४६१५/प्र.क्र.२०८(१)/म.शि.-२, dt. 03.12.2018: Direction -2020."
- 2. This Direction shall come into force from the date of its issuance.
- 3. In this Direction, unless the context otherwise requires:
  - (i) "Act" means "the Maharashtra Public Universities Act 2016"
  - (ii) "NCTE" means "National Council for Teachers Education" constituted under National Council for Teachers Education Act, 1993 (73 of 1993)

- (iii) "Affiliated" colleges / Institutions" mean "Government /Non-Government colleges/Institutions affiliated / recognized by the University on aided or un-aided basis, running the courses fall within the purview of National Council for Teachers Education"
- (iv) "Government Resolution" means "Government Resolution No. B.Ed. ४६१५/प्र.क्र.२०८(१)/म.शि.-२, dt. 03.12.2018.
- (v) "NCTE Regulations -2014" and 2017" means "National Council for Teaching Education 2014 Published vide Notification No.F.51-1/2014-NCTE (N&S) dated 28 Nov. 2014 and amended Notification No. F 51-1/2015 NCTE (N&S) dated 29<sup>th</sup> May, 2017.
- 4. (a) From the date of enforcement of this Direction, the provisions in the above NCTE Regulation 2014 and 2017 with Government Resolution dt. 3<sup>rd</sup> Dec. 2018 shall prevail and the provisions made in the earlier Statute, Ordinances, Regulations or Directions shall, to the extent to which they are inconsistent with the provision of above NCTE Regulation 2014 and 2017 with Government Resolution dt. 3<sup>rd</sup> December, 2018,be invalid.
