# Subject: - Amendment in Ordinance No 16 of 2007 and in Direction no 66 of 2010.

Whereas, the Ordinance No 16 of 2007 in respect of the procedure for providing photo copy/ies of Answer-book/s to an examinee and the procedure for redressal Mechanism Ordinance ,2007 is in existence and Whereas, the Direction No 66 of 2010 in respect of "Reassessment of Answerbooks of examinees without obtaining Photocopy of Answerbooks on their demand" is in existence, serial no 19 of the said Ordinance and serial no. 13 of the said direction provides that "if the marks awarded by the subsequent examiner vary/deviate on either side by more than 5 percent (including 5 percent) of the total marks precribed and less than 15 percent (including 15 percent) of the total marks prescribed ,determined on the basis of marks given in the original result then the original marks of the applicant examinee shall be changed and marks awarded by the subsequent examiner shall be awarded to the examinee.

#### AND

Whereas, the Ordinance No 16 of 2007 in respect of the procedure for providing photo copy/ies of Answer-book/s to an examineee and the procedure for redressal Mechanism Ordinance, 2007 is in existence and Whereas, the Direction No 66 of 2010 in respect of "Reassessment of Answerbooks of examinees without obtaining Photocopy of Answerbooks on their demand" is in existence, serial no 20 of the said ordinance and serial no 14 of the said direction provides that "if the marks awarded by the subsequent examiner vary/deviate on either side by more than 16 percent (including 16 percent) of the total marks prescribed then the answerbooks shall be reassessed by the second subsequent examiner and the mean of the higher two examiners be considered to award the marks to the examinee.

## AND

Whereas, the Board of examinations in its meeting held on 06<sup>th</sup> June 2014 vide Item no. 24 has accepted the following recommendation of the Central Assessment Programme committee.

# (a) Ordinance No.16/2007 Part-II (The Procedure For Redressal Mechanism ) Serial No.19 and Direction No.66/2010 Serial No.13:-

If the marks awarded by the subsequent examiner vary/deviate on either side by more than 5 percent (including 5 percent) of the total marks prescribed and less than 18 percent (including 18 percent) of the total marks prescribed determined on the basis of marks given in the original result then the original marks of the applicant examinee shall be changed and the mean of the two Examiners i.e. the original Examiner and the subsequent Examiner shall be awarded to the Examinee.

# (b) Ordinance No.16/2007 Part-II (The procedure For Redressal Mechanism) Serial No.20 and Direction No.66/2010 Serial No.14:-

If the marks awarded by the subsequent examiner vary/deviate on either side by more than 19 percent (including 19 percent) of the total marks prescribed then the answerbooks shall be reassessed by the second subsequent examiner and the mean of the closer two examiners be considered to award the marks to the examinee.

## AND

Whereas, the Academic Council in its meeting held on 06<sup>th</sup> May 2015 vide Item no. 43 has accepted the recommendation of the board of examinations.

### **AND**

Whereas, the Board of Examinations in it's meeting held on 21<sup>st</sup> August 2015 vide Minutes "Right to Information Act no.3" has resolved the following provision about revaluation of the marks.

"If the examinee has applied for revaluation; of his/her original result, he/she shall be awarded higher marks out of the two i.e. the original marks or marks obtained after revaluation. Hence, the ordinance is to be amended.

#### AND

Hereinafter, the examinees need not to enclose original marksheet alongwith the application form of reassessment but must have to enclose the photocopy of the original marksheet. The revised statement of marks shall be given to him/her only if the marks are increased after revaluation, and only on surrendering of his/her original statement of marks to the Asstt. Registrar (Examination) of the University.

#### AND

Whereas the matter is required to be regulated by amending the ordinance no 16 of 2007 and Direction No. 66 of 2010 and making of an Ordinance in this respect is likely to take some time.

### AND

Whereas, the matter is to be implemented from Winter 2015 examination.

Now therefore, I, Dr.Mohan Khedkar, Vice Chancellor of Sant Gadge Baba Amravati University in exercise of powers confirmed upon me under sub section (8) of Section 14 of the Maharashtra Universities Act,1994, hereby direct as under:-This Direction may be called as **Amendment in Ordinance No. 16 of 2007 and in Direction No. 66 of 2010.** 

- 1. This direction shall come in to force from Winter 2015 examination.
- 2. The serial no. 19 of Ordinance No. 16 of 2007 and serial no. 13 of Direction No. 66 of 2010 should be replaced by following para.

"if the marks awarded by the subsequent examiner vary/deviate on either side by more than 5 percent (including 5 percent) of the total marks precribed and less than 18 percent (including 18 percent) of the total marks prescribed, determined on the basis of marks given in the original result then the original marks of the applicant examinee shall be changed and the mean of the two examiners i.e. the original examiner and subsequent examiner shall be awarded to the examinee."

- 3. The serial no 20 of ordinance No 16 of 2007 and serial no 14 of Direction No of 66 of 2010 should be replaced by following para
  - "if the marks awarded by the subsequent examiner vary/deviate on either side by more than 19 percent (including 19 percent) of the total marks prescribed then the answerbooks shall be reassessed by the second subsequent examiner and the mean of the closer two examiners be considered to award the marks to the examinee"
- 4. The serial no. 18 of Ordinance No. 16 of 2007 and serial no. 12 of Direction No. 66 of 2010 should be substituted by following para:-

If the marks awarded by the subsequent examiner vary/deviate on either side by less than 4 percent (including 4 percent) of the total marks prescribed, determined on the basis of marks given in the original result, then the applicant examinee shall be awarded the higher marks only, obtained after revaluation or the original marks.

5. The examinees need not to enclose original marksheet alongwith the application form of reassessment. The revised statement of marks shall be given to him/her, only if the marks are increased.
