**Subject : Ammendment to Direction No. 12/2020, dt. 4<sup>th</sup> August, 2020 on Admission of students to all Undergraduate Courses and admission to 3<sup>rd</sup> and 5<sup>th</sup> Semester / Final year Post Graduate Degree / Diploma Courses Academic Session – 2020-2021.**

Whereas, the Direction No.12/2020, on the subject mentioned above has been issued u/s 12(8) of Maharashtra Public Universities Act, 2016 in which under para 3(ii) the last date for Admission with the permission of Vice-Chancellor has been prescribed as 30 September, 2020 on the basis of Academic Calendar 2020-21 as approved by the Academic Council and notified vide Notification No.52/2020.

AND

Whereas, UGC has now issued Guidelines in the month of September, 2020 on Academic Calendar for the First Year of Under-Graduate and Post-Graduate Students of the Universities for the Session 2020-21 in View of COVID-19 Pandemic in which last date to complete Admission Process of the Students to the Courses in Academic Session 2020-21 is given as 31<sup>st</sup> October, 2020.

AND

Whereas, in view of above UGC Guidelines the University has issued Notification No.77/2020 dt. 15.10.2020 in continuation to earlier Notification No. 52/2020 thereby the Direction No. 12/2020 is to be amended.

AND

Whereas, the matter pertains to the Ordinance prescribing of which is time taking Process and meeting of the Academic Council is not scheduled, the Vice-Chancellor has extended the last date u/s 12(7) of the Act.

Therefore, I, Dr. Murlidhar Chandekar, Vice-Chancellor, Sant Gadge Baba Amravati University, in exercise of powers conferred upon me under Sub-section (8) of Section-12 of the Act, do hereby direct as under :-

1. This Direction may be called ‘Amendment to Direction No.12/2020, dt. 4<sup>th</sup> August, 2020 on Admission of students to all Undergraduate Courses and admission to 3<sup>rd</sup> and 5<sup>th</sup> Semester / Final year Post Graduate Degree / Diploma Courses Academic Session – 2020-2021.’
2. This Direction shall come into force with effect from the date of its issuance and be operative exclusively only for 2020-21 session.
3. In para 3(ii) of Direction No.12/2020, dt. 4<sup>th</sup> August, 2020 the date ‘ 30<sup>th</sup> September, 2020’ appearing in the last of this para 3(ii) be substituted by the date ‘ 31<sup>st</sup> October, 2020’.
4. As directed in Direction No.12/2020 in clause (vi) of Para-3, it is reiterated that no admission to 1<sup>st</sup> Semester/ First Year of Post Graduate Courses be made till the University directs in this respect.
